Last Week's meeting recap:

Speaker: Brent Barry, Phoenix-Talent SD Superintendent, **Topic**: The Phoenix in the Phoenix-Talent School District: Rebuilding from the ashes.

Brent Barry, Phoenix-Talent Schools superintendent and Oregon s Superintendent of the Year, discussed the numerous obstacles the district was forced to overcome in the past year, with the Almeda fire coming on top of the Covid pandemic.

As the district prepared to deal with Covid and distance learning in September 2020, the Almeda fire swept through Talent and Phoenix, destroying the homes of 700 district students. Brent and his team of educators leapt into action and within a few days had

contacted the families of all students to determine their situations. Most of the 2,500 homes lost in the two communities were in mobile home parks and the families involved were often in low-income situations.

In the days and weeks following the fire, the school district helped organize donations to get the families through the immediate aftermath and worked with a large number of community partners to assist with longer-term issues such as housing. Those community connections were critical to the district response. Working with Rogue Retreat they were able to obtain two dozen RVs for families to live in temporarily. Rogue Credit Union donated \$150,000 to put Chromebooks in the hands of students and the Eagle Point School District provided a building for services for the many P-T students who wound up in White City. By the time donations began to wind down, the district had received financial contributions amounting to \$2.2 million to be distributed to the affected families.

In the midst of all that, the district found a bright spot, opening its new high school and putting smiles on the faces of students and staff alike.
