PROGRAM



Our own Nancy Richardson spoke to us about Intellectual Properties, Patent Law, and related matters. Nancy has a background in chemistry but also became a Patent Agent. She is not an attorney and cannot represent a client in court, but she can be an expert witness. We have had Patent Laws in this country since 1790. There are copyrights which expire 70 years after the person's death. There are Design Patents such as the Coke bottle. These need to be renewed every 4 years. There are plant patents for plants that are sexually reproduced such as trees and vine. Roses are an example. Then there are the non-sexually reproduced plants such as tulips and onions.

To obtain a patent one must fairly disclose, provide a description, how to use, how to make, why it is useful, why it is unique. One then makes a claim and files. It is either accepted or rejected. A paper clip was rejected, but the machine to make them was accepted.
