## **PROGRAM**



Jared Eisenstat, attorney, and Rossmoor resident. His topic was "Sentenced to Life With Possible Parole." Jared described his important, many years work, as a "Lifer Attorney," also called a California Parole Consultant Attorney. He described parole hearings by which those convicted of crimes, such as murder, work with his assistance to obtain parole. The emphasis during the hearing is on what the person has done during prison rather than what the person did before prison. Most of his clients are in their 50's. Just getting older is "rehabilitative," according to Jared.

He also states that almost everyone who is granted parole in California is not an "unreasonable risk" to re-offend. Parole law according to Jared is "not supposed to be who you were, but who you are now."

The parole hearings now because of Covid-19 are virtual. There is no judge or jury. What you have done in prison, such as getting your G.E.D., involvement in counseling, rehabilitation, job training, and arranging for transitional housing upon release, are all factored into the parole process.

Jared told us that he will be leaving Rossmoor moving to Angels Camp. We wish him well in his move and continued success in his important work.
