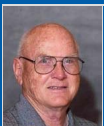

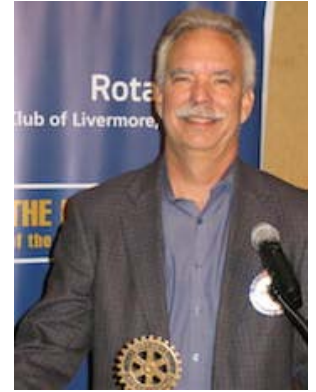

Update on New Council Chambers and Emergency Operations Center -
Marc Roberts

Marc introduced us to impressive progress in construction of the new John Shirley Council Chambers and the Emergency Operations Center (EOC). There will be a ribbon cutting ceremony July 13 in the morning which will be open to the public. The combined building will be capable of seating 200 people, with 80 people in the new EOC. The EOC will operate using an Incident Command System modeled on state and national systems. Livermore and Alameda County are developing a Community Emergency Response Team.
