Darryl Dunn

CEO & General Manager, Rose Bowl Stadium

Darryl Dunn has served as the CEO & General Manager of the Rose Bowl Stadium since 1999.

He is responsible for managing all aspects of the facility, including contract negotiations with prospective events, ongoing relationships with existing tenants and all financial, marketing, and operational needs for the stadium. He is extensively involved in long range planning for the facility and spearheaded the planning and execution of a \$183 million renovation for the historic facility beginning in 2011. He negotiated thirty-year agreements with tenants UCLA and the Tournament of Roses and long-term agreements with sports marketing companies IMG and Legends. In the spring of 2016, Dunn oversaw the approval of a multi-year music and arts festival at the Rose Bowl beginning in 2017 in partnership with worldwide promoter AEG.

During his tenure, the Rose Bowl has hosted four National Championship Games in college football), the annual Rose Bowl Game, Copa America,

numerous international soccer matches, including hosting the national teams of Brazil, Columbia, Mexico and the United States, as well with clubs such as Barcelona, Real Madrid and

Manchester United. Concerts have included the record breaking U2 2009 event, as well as Justin Timberlake, Beyoncé, Jay Z, Kenny Chesney and many more.

Mr. Dunn serves as the primary representative of the City of Pasadena to American Golf Corporation related to the operation and long-term planning for Brookside Golf Course, a 36-hole public golf course.

Prior to coming to the Rose Bowl, Mr. Dunn worked for the Los Angeles Lakers, Los Angeles Raiders, Los Angeles Clippers and World Cup 1994 Organizing Committee.

Dunn has been involved with several local and national non-profit organizations and serves as the honorary co-chair of the annual NAACP event held in Pasadena. He has been recognized by the Los Angeles Business Journal as one of the 500 most influential people in Los Angeles from 2016-2020. He has received numerous community, business and neighborhood awards for his commitment to others. A native of Connecticut, Mr. Dunn resides in Pasadena and is married and has two children.

THE SCOOT ZONE

After a bit of technical dithering by the Zoom Team, President Ken Joe called the meeting to order from the University Club shortly after the stroke of noon. Ross **Jutsum** showed us a photo of his newest twin grandsons, Adam and Noah, and led us in singing the WWII classic White Cliffs of Dover, followed by My Country Tis of Thee and the Pledge of Allegiance. Lisa Cavalier gave the invocation in the form of a recording of Rise Up sung by a young participant at the Boys and Girls Club national conference. She closed by saying "we will rise up, despite the pandemic and everything

going on - we will rise up and be better than ever, hopefully sooner rather than later."

President Kenintroduced **Leah Snell**, Program Committee Co-Chair, who introduced our speaker. Kerri Murray, President of ShelterBox USA and member of Montecito Rotary, said she became aware of ShelterBox and Rotary ten years ago when doing earthquake relief in Haiti. She joined the organization five years ago and became a Rotarian shortly thereafter. This year is ShelterBox's 20th anniversary.

One of the biggest issues facing the world is the massive displacement of people from conflict situations and natural disasters. There are 88,000,000 displaced people – more than ever in history. Twenty years ago the founders, who were Rotarians, formed the organization based on the premise "what do you need to save your life when you have lost everything in an instant?" The center of gravity for what we do is shelter.

The tent is the place the family will call home for months, as well as the things people will need including water purification supplies, cooking utensils, blankets, ground mats, mosquito nets, tools, children's activity set. This was the classic for many years: One box for one family. Over the years, Kerri explained, they have moved beyond one box.

Kerri explained that there are a variety of tents for different circumstances. "We've stayed true to our focus on shelter," she said. "The other aid items allow us to serve thousands of families

at a time, including a Shelter Kit with tarps and tools that will allow us to build a single

room structure or repair a damaged home. The intent is always the same: To provide a family with a place to call home."

The importance of shelter has only increased during COVID-19. The three most important mitigating factors regarding COVID-19 are health, hygiene, and shelter. In many of the places ShelterBox serves there is very little ability for hygiene or social distancing, so the work has become much more logistically complex and they have had to adapt the aid packages to assure they do no harm.



move out of crowded communal centers."

ShelterBox is also filling in gaps with healthcare facilities, for example by creating triage units with our shelter kits where hospitals have become overcrowded.

How is the work possible? "Twenty years ago" said Kerri, "our founders created a disaster training program, largely of Rotarians, all over the world, to train

ShelterBox Response Team members. One in 30 people makes it through the program to become a first responder. In disasters we coordinate with U.N. Shelter Cluster. Because we are so highly trained, we often get sent to the most remote locations. We have an MOU with Rotary in every country where Rotary is present so when a disaster strikes we are there."



In places like Syria and Bangladesh, living situations are very dense and crowded. Kerri explained, "we are doing masks and gloves and making our distribution events smaller and emphasizing hygiene both during the distribution and in the aid packages and via education. Our goal is to continue our work, particularly in places like Cameroon where there are many refugees living in large refugee camps. In many places we are the only provider of tents to allow families to

It is a massive global effort, she emphasized, "and Rotary is in the DNA of everything we do at ShelterBox." Some notable deployments: "The Haiti earthquake displaced 1.5 million people and they really needed our help. We were able to serve hundreds of thousands of people. Nepal earthquake was a big one. Syria has been the longest response in our history: Continuous since 2012. There were a million people displaced last

winter from December to April: Children were literally freezing to death. We do a winterizing project every year to try to prevent this. Give out thermal onesies for the babies. Our work never makes the headlines but it is lifesaving for the families. We were nominated for the Nobel Peace Prize in 2018 and 2019."

Occasionally ShelterBox does respond in the U.S., but it's the exception not the rule because ShelterBox concentrates its work in the poorest places. Kerri said, "we did respond in Texas for Hurricane Harvey where there were 15,000 people in an evacuation center set up for 5,000 people and it was a very desperate situation."

ShelterBox works extensively in the Lake Chad Basin in Africa – one of the poorest places in the world. Kerri showed a photo of Esther, who was living in Nigeria in 2014 when the Boca Haram fighters stormed her village and her home. She made it to the border and ended up in a camp where ShelterBox provided her with a shelter kit. She shared with our team that her first two years in the camp were awful but what changed her life was taking a sewing class. She has married in the camp and had children, and now she supports her family with her sewing. Kerri shared a quote from Esther: "Anytime I see somebody wearing something that I sewed, it makes me happy. I can now take care of some family needs, like cooking and other things."

Significantly, ShelterBox does not expect any of its tents or equipment to be returned: "Our aid is an unconditional gift and includes a deed of ownership."

Kerri concluded as follows: "We've had more than 200 deployments in 107 countries, and served 1.6 million people since 2000. We have earned four stars on Charity Navigator, and most of our support is from private individuals." If you would like to get involved, contact her at kmurray@shelterboxusa.org 805-452-7599.
