Rhonda Sanders is the CEO of the Arkansas Foodbank. The Arkansas Foodbank acquires, processes and distributes food and other services to 33 counties in Arkansas. Under her leadership the Arkansas Foodbank has more than doubled its distribution of food, expanded its facility and merged with the Arkansas Rice Depot to form a new and stronger organization focused on helping those in need have access to nutritious food. Currently Rhonda serves as a Co-chair of the Feeding America Contract Task Force for the 200 food banks in the network and serves on the Policy Engagement and Advocacy Committee for Feeding America. Rhonda also serves as chair of Arkansas State VOAD to coordinate disaster response efforts in the state.

Previously Rhonda was the Executive Director of the Arkansas Hunger Relief Alliance, Arkansas state association for food banks, for four years and worked for Arkansas Advocates for Children & Families for 14 years where she served as the Director of Health Policy and Legislative Affairs. She has spent most of her professional career working on policies and initiatives to improve access to nutritious foods and health for citizens of Arkansas.

In November 2020 she was elected to serve on the Bryant City Council and is a board member for the Greater Bryant Regional Chamber of Commerce. She is a graduate of Ouachita Baptist University with a degree in Accounting and received a Master in Public Health from the UAMS College of Public Health. She is married to her husband of 32 years and has a daughter, son, son-in-law and the best prize in life, a 19 month old grandson.
