#### AR Lt. Gov. Tim Griffin



Rotarian and Rep. Les Warren introduced our speaker, Arkansas' Lt. Governor, Tim Griffin, a Magnolia native and Colonel in the US Army Reserve. Griffin says that Hot Springs is a special place for him, as he spent some of his youth here when his father served as Youth Director for 2nd Baptist Church and he and his wife were married here with their rehearsal dinner at our club's home: the Arlington Hotel's Crystal Ballroom.

As Lt. Governor, he quickly cut the LG's budget by 16% and staff by 50% and those cost reductions have



remained in place for the entire six years he has been in this office.

Lt. Governor Griffin also spoke about three pending pieces of legislation that are on his radar that are "Pandemic specific":

\* Taxation of the PPP (Paycheck Protection Program) loans - when the federal government issued these loans, they were presented as federal income tax free loans. But according to law, states must take action to make these loans state income tax exempt. The guidelines for these loans were that all loan dollars must be spent. So if businesses wanted to be responsible and save some of this money to pay state income tax, they would violate the guidelines. If the state chooses to tax the loans, the money will come out of the business owner's pocket during a financially stressful time. Both Griffin and Rep. Warren agreed that voting for this bill is a "no brainer" to allow these loans to be state income tax exempt. So far this bill has passed in the House Revenue & Tax Committee and will soon be going to the Senate for a vote.

\*Taxation of Unemployment Benefits: Prior to 2017, unemployment income was not subject to state income tax. When the state decided to exempt military retirement from state income tax, instead of finding the savings with government general revenue funds, one of the "pay fors" that they found was to remove the unemployment benefit state income tax exemption. Now with a historic number of Arkansans receiving unemployment benefits due to the pandemic, unfortunately, the state does not have the capability to withhold taxes on these benefits. So recipients will be responsible for the entire amount at once - during an already stressful financial time. The legislature is considering a one time waiver for 2020-2021 and also a fix to withhold state income tax in the future. Rep. Warren added that the consensus of Legislators is that we need to allow these people to use these dollars to get through this difficult time and then fix the withholding problem.

\*Concerning the Governor's Emergency Powers - there is legislation seeking to curtail the authority of the Governor in the state of emergency. Generally, a state of emergency is limited to a few days or weeks due to incidents, accidents or natural disasters. The Pandemic is so different and most

states were not regulatorily or statutorily ready for this. There are many passions and different views on this, but it needs to be addressed one way or another. Some legislators feel they haven't been included in the pandemic decision making process, so there are several proposals floating around including limiting emergency power to 30 days unless it is extended by vote of the Legislature and another requiring approval by Legislature on certain rules. One piece of Legislation that has already passed is a bill curtailing the authority over Churches or places of worship. Rep. Warren feels this is a very difficult situation as he has constituents who feel the Governor has done too much and some say he hasn't done enough. The one piece of legislation that he has seen on this is extremely involved. You want a Governor who can lead the people in times of emergencies, but at the same time, you want the people to have a voice. Both Warren and Griffin agree that it is a very difficult matter and there probably isn't an easy fix, but bottom line: "We have to take care of our people".
