Engage In Rotary - Visit our Website's Sign-Up Genius Registration Portal


At Rotary, we use a registration site called Sign-Up GeniusTo register for a committee, fellowship and service opportunities, to be an assistant at a Rotary meeting, to register to introduce a new member, etc.

Simply go to our website: **nashvillerotary.org** and click on the sign-up **genius icon.** Once you click on the site, at the top of the page, there are several 'tabs'. Each tab contains details, dates, and options for the opportunity.

- Register for meetings (such as orientation or committee meetings)
- Volunteer events (such as Feed the Need, monthly backpack project at Second Harvest Food Bank, and others as they are scheduled)
- Fellowship events (we host Rotary after Hours events about every 6 weeks. These are small, informal gatherings at local venues, this is a pop in, stay as long as you want, cash bar, appetizers provided, networking events)
- Assist at a Monday meeting (each week, we need someone to offer an invocation, scan member badges as they
 arrive, greet members and guests, hand-out parking stickers, and register and introduce visiting Rotarians. These
 are excellent ways for new members to get involved quickly and easily)

Commerce Street Garage, section A (entrance on Commerce between 3rd and 4th Avenues) and section B (entrance on Commerce between 2nd and 3rd Avenues).

NOTE – Bring your ticket into the meeting to have a validation sticker placed on your ticket to exit the garage

NOTE –Occasionally, there are issues with the kiosks and you are advised to make a note saying, Rotary Member Parking and leave it on your dash when parking at surface lots.
