David Ewing, CEO Nashville History on Tour "20 Things You Did Not Know About Nashville African American History"

David Ewing is the CEO of Nashville History on Tour a private upscale Nashville history tour company which also does history consulting for developers, businesses, restaurants, hotels and local families. David has discovered many hidden history items in Nashville including the lost mugshots of Congressman John Lewis when he was arrested here as a Fisk University student during the nonviolent lunch counter sit-ins at Woolworth. He also discovered and helped restore the original name of Frederick Douglass Park which had just been changed to Douglas Park decades ago.

David is a ninth generation Nashvillian and has the largest private collection of Nashville memorabilia. The Nashville Scene last year named him the "Best Historian" in the Best of Nashville issue.

This speech is a follow up to David's popular Rotary address last year "30 Things You Did Not Know About Nashville History." His new speech will explore interesting local African-American achievements in Nashville.
