How Music City Keeps Scoring:

NFL Draft, NASCAR and More

Collaboration, Cooperation and Strategic Planning

Butch Spyridon has served as president and CEO of the Nashville Convention & Visitors Corp (NCVC) since 1991. Under his leadership, Nashville's hospitality industry has evolved into a year-round global destination for convention, business and leisure visitors. Hospitality is the city's second largest industry, attracting a record 15.2 million visitors in 2018 and generating \$6.5 billion in direct visitor spending. At the end of April, the city will host the NFL Draft, which is expected to be the largest event in Nashville and the state of Tennessee given the anticipated attendance of 100,000 per day over three days, coverage on three national networks and an estimated 1,000 credentialed media members. The Music City brand and an emphasis on hosting large events to attract visitors helped the city land the NFL Draft. For the first time, the football-centric event will include live music - and it's all free and open to the public.
