VIRTUAL ROTARY-JUNE 1, 2020: DR. JEFF BALSER, PRESIDENT & CEO, VANDERBILT UNIVERSITY MEDICAL CENTER

As President and CEO of VUMC, he reports to an independent board of directors, while continuing to serve as Dean of Vanderbilt's Medical School. He presently co-chairs the Blue Ridge Academic Healthcare Group and is chairing the 50th year anniversary annual meeting celebration of the NAM while serving on the academy's governing council. Dr. Balser serves on the boards of VUMC, Tulane University, the Center for Medical Interoperability, and Varian Medical Systems. In 2008 he was elected to the National Academy of Medicine (NAM), and later that year was named the eleventh Dean of Vanderbilt's School of Medicine since its founding in 1875. In 2009, he was also named Vice Chancellor for Health Affairs with executive responsibility for all health-related programs at VUMC. Dr. Balser has led VUMC through a period of marked clinical service and facilities growth, including a 50% expansion of inpatient capacity to over 1400 beds, the first offcampus inpatient facility acquisitions in 2019, and the Southeastern region's largest and most comprehensive provider-led health network with over 60 hospitals and 6700 clinicians across 5 states.



SPECIAL ACTION TO BE TAKEN BY CLUB MEMBERS

Dear Rotarians,

Reviewing the constitution and is a regular practice of the board and reflects good governance. Any proposed changes to our Club's bylaws require a vote of the membership after an approved motion by the Board of Directors. At the April meeting of the Board of Directors, a motion was made and approved to amend Article VI, Section 7 of the Rotary Club Of Nashville Constitution. Section 7 regards membership of holders of Public Office and currently states:

Section 7 — Holders of Public Office. Persons elected or appointed to public office for a specified time shall not be eligible to active membership in this club under the classification of such office. This restriction shall not apply to persons holding positions or offices in schools, colleges, or other institutions of learning or to persons who are elected or appointed to the judiciary. Members who are elected or appointed to public office for a specified period may continue as such members in their existing classifications during the period in which they hold such office.

It is the desire of the Board of Directors to add the following to Article VI, Section 7: The Governor of the State of Tennessee and the Mayor of the Metropolitan Government of Nashville & Davidson County are eligible to apply for membership while serving in office.

A call for a vote from members regarding this amendment will be taken during our meeting on Monday, June 8th.
