### VIRTUAL ROTARY-JUNE 8, 2020: ENTREPRENEURS WHO SOLD

The Exit, Part 1 will feature a panel of local entrepreneurs who sold their companies. Join us to learn more about their stories, the lead up to the decision to sell and what they are up to now. Lori Becker, market president and publisher of the Nashville Business Journal, will moderate the panel.

#### Panelists:

**Beth Chase**, Senior Managing Director & Partner, Ankura–Beth was the founder and CEO of c3/consulting prior to its acquisition by Ankura in 2018.

**Darrell Freeman**, Roughly 25 years after launching Zycron Inc. fresh out of college, Darrell S. Freeman sold one of Nashville's largest information technology consulting firms to BG Staffing out of Plano, TX.

**Charlie Nelson** is the Co-Founder of Nelson's Green Brier Distillery in Nashville, TN. In the summer of 2006, Charlie and his older brother Andy stumbled onto a largely-forgotten chapter of their family's history: Their great-great-great grandfather, Charles Nelson, had been one of the most successful whiskey distillers in pre-prohibition America.

Moderator: Lori Becker is market president and publisher of the Nashville Business Journal, taking the helm in August 2019 at the region's preeminent business media company. She previously was editor-in-chief for seven years, leading the NBJ's team of journalists who cover Music City's business community. Lori joined the Business Journal in 2008 as managing editor, after more than a decade with daily newspapers.



#### SPECIAL ACTION TO BE TAKEN BY CLUB MEMBERS

Dear Rotarians,

Reviewing the constitution and is a regular practice of the board and reflects good governance. Any proposed changes to our Club's bylaws require a vote of the membership after an approved motion by the Board of Directors. At the April meeting of the Board of Directors, a motion was made and approved to amend Article VI, Section 7 of the Rotary Club Of Nashville Constitution. Section 7 regards membership of holders of Public Office and currently states:

Section 7 — Holders of Public Office. Persons elected or appointed to public office for a specified time shall not be eligible to active membership in this club under the classification of such office. This restriction shall not apply to persons holding positions or offices in schools, colleges, or other institutions of learning or to persons who are elected or appointed to the judiciary. Members who are elected or appointed to public office for a specified period may continue as such members in their existing classifications during the period in which they hold such office.

It is the desire of the Board of Directors to add the following to Article VI, Section 7: The Governor of the State of Tennessee and the Mayor of the Metropolitan Government of Nashville & Davidson County are eligible to apply for membership while serving in office.

A call for a vote from members regarding this amendment will be taken during our meeting on Monday, June 8th.

#### Nashville Rotary's COVID-19 Response
