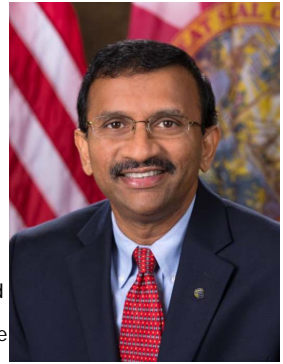

Kancharla has a Master's in Business Administration from the University of South Florida and is certified by the American Association of Port Authorities as a Professional Port Manager (PPM). He is an alumnus of Leadership Florida, Leadership Tampa, and represents the port of Tampa on various committees involved in freight movement, intermodal planning, finance, trade, logistics and the maritime industry. Kancharla was appointed by the U.S. Commerce Secretary to serve on the U.S. Department of Commerce Advisory Council on Supply Chain Competitiveness. He is one of the Miami Herald's 2019 Florida Influencers. Kancharla is active in the Greater Tampa Chamber of Commerce, Tampa Bay Partnership, Florida Council for Public Private Partnerships, Government Finance Officers Association, Intermodal Association of America Marine Division, and American Association of Port Authorities. He advises or serves on the boards of Floridians for Better Transportation, Economic Club of Tampa Bay, the USC Marshall Center for Global Supply Chain Management Executive Board, and the USF Center for Urban Transportation Research. Kancharla was a Global Advisory Council member for Columbia-based Innovation in Logistics Supply Chain and Port Management (LOGPORT), and was a U.S. Maritime Administration Strong Ports focus group member. He is an active Rotarian and serves on several community boards including Feeding America.

Stano Foundation Request

The foundation sends care packages to troops deployed and due to the circumstances of Covid not only are her supplies greatly reduced but her ability to raise donations has also been negatively affected. This was brought to our attention when Jason Contino reached out to her to find out how to get some of the packages delivered to a friend he has deployed currently in Afghanistan.

Therefore, we are asking if members can bring in both supplies and monetary donations (to cover the costs of the shipping). Each box cost approximately \$20 to ship and we are going to ship 20 boxes.

District News: PDG, Thrill-Seeker Pedaling Cross-Country to End Polio ♦ Again

Nick Hall, a 72-year-old Rotarian, psychoneuroimmunologist and motivational speaker, kicks off his third cross-country bicycle trip June 3. He is riding solo without a support van. The Seattle to Tampa, FL route takes Hall over 6,000-foot tall mountains.

Why is he doing this? He ♦s helping end polio. He ♦s also been a self-described thrill seeker since childhood. In fact, he'll stop in South Dakota to wrestle an alligator. Again. In the 1960s, Hall wrestled alligators as a summer job in the Black Hills Reptile Garden in Rapid City before pedaling his bicycle to Massachusetts for the fall semester.

Hall completed two other cross-country End Polio Now excursions. The 2015 coast-to-coast ride began in San Diego and ended in St. Augustine, FL. In 2018 Hall rode from Temple Terrace, FL to the Rotary International Convention in Toronto, Canada. Together, the trips raised nearly \$45,000 to end polio. This year, Hall is reaching out to Rotary clubs along the route inviting them to host social distance-friendly cheering sections as he rides by raising awareness and more donations to end polio.



The Rotary Foundation, The Bill and Melinda Gates Foundation, and several governmental and non-governmental agencies have eradicated in all but a few countries. The virus persists in remote Asia and Africa. In 2019, one case was diagnosed in Europe. Hall believes ending polio is within reach for all humankind. He vividly remembers polio epidemics of his youth when public pools were closed to prevent spreading the virus.

Nick started the 2020 Seattle-to-Tampa tote board with a personal donation of \$3,216--\$1 for every mile. Everyone can follow Nick's ride using a link to his GPS: <https://maps.findmespot.com/s/25QJ>. Daily updates about the people he meets and sights he sees may be found on Facebook under Pedal Power to End Polio, @PedalPowerEndPolio on Instagram and @PedalPwrFL on Twitter.

Nominations for District Governor 2023-24 Now Open!

STATUS

The Governor is an officer of RI nominated by the clubs of a district and elected by the convention of RI. The governor's term of office begins on 1 July and continues for one year or until a successor is elected and qualified.

QUALIFICATIONS

In addition to the qualifications of governor nominee (below), a governor, at the time of taking office, must have completed seven years of membership in one or more clubs and have attended the governors-elect training seminar and International Assembly.

DUTIES

The district governor's responsibilities can be found in Lead Your District: Governor (233). This manual is updated annually. ([CLICK HERE FOR CURRENT MANUAL](#)) In addition to fulfilling their responsibilities, district governors are expected to adhere to the Rotary Code of Ethics.

GOVERNOR NOMINEE MUST;

1. At the time of taking office must have been a member of one or more Rotary Clubs for at least seven years.
2. Have full qualifications for membership in the strict application of the club membership provisions, and have a classification whose integrity is without question.
3. Have served as president of a club for a full term or be a charter president of a club, having the full term from the date of the charter to June 30, provided that this period is for at least six months.
4. Demonstrate willingness, commitment, and ability, physically and otherwise, to fulfill the duties and responsibilities of the office of governor as provided in RI Bylaws section 15.090.
5. Demonstrate knowledge of the qualifications, duties and responsibilities of governor as prescribed in the RI Bylaws, and submit to RI, through its general Secretary, a signed statement acknowledging a clear understanding of them. This statement shall also confirm that the Rotarian is qualified for the office of governor and willing and able to assume the duties and responsibilities of the office and to perform them faithfully.

Clubs who wish to submit the name of a candidate for consideration should, first, vote at a regular meeting to submit the name of the candidate, then complete and forward the District Governor-Nominee Application Form to DG Darren 'Kip' Kipnis before 10/31/20
