Eric Corliss is Regional Chief Executive Officer and will be leading a team of staff and volunteers in the Central Florida Region. He began his career with the Red Cross in 1996 and has served in a number of capacities at the local, state, division, and national level. Most recently, Corliss served as the Executive Director for the Hurricane Irma Recovery Program leading a team that provided financial assistance in Florida, Georgia, and South Carolina and provided grants to 45 organizations working on the long-term recovery for Hurricane Irma.

Eric is an Army veteran who joined the Red Cross as a caseworker in the Service to the Armed Forces (SAF) program. His commitment to the organization started as a teenage youth volunteer assisting with disaster response efforts. The Red Cross has been an important part of Eric's personal and professional life for many years. His leadership and management experience in various roles within the organization will be an asset to the dedicated team of staff and volunteers in Central Florida.

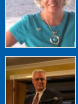

foundations efforts to support our troops overseas. The foundation sends care packages to troops deployed and due to the circumstances of Covid not only are her supplies greatly reduced but her ability to raise donations has also been negatively affected. This was brought to our attention when Jason Contino reached out to her to find out how to get some of the packages delivered to a friend he has deployed currently in Afghanistan.

Therefore, we are asking if members can bring in both supplies and monetary donations (to cover the costs of the shipping). Each box cost approximately \$20 to ship and we are going to ship 20 boxes.

One of the particular items that was requested were black or brown boot socks. Paula has enough of the Bombas socks to add to the packages. But we will still need:

- ◆ Flavor packets to add to water bottles (powder)
- ◆ KCups
- ◆ Snacks (like beef jerky etc)

We will collect the supplies over the next 2-3 weeks, but will need volunteers to pack the care packages in 3 weeks.
