Rotary International and Zone COVID 19 Guidance



Important Message from DG Innes Richards,

Dear District Leadership,

We recently received guidance from Rotary International on meetings during the COVID-19 crisis. Some of this guidance was from informal text messages on WhatsApp from the Zone Directors, and other guidance was from the meeting minutes of the R.I. Board of Directors' meeting on April 21-24. As this is an evolving situation, the R.I. position may change over the next few months. Current guidance is described below:

Important Points For Rotary Clubs: (From Zone Directors via WhatsApp)

- R.I. strongly discourages all in-person meetings through December 31, 2020.
- Beginning in July, the club and district insurance policy more than likely will NOT COVER COVID-19 related liability.

From the Board of Directors' Meeting Minutes:

- "The health and safety of all participants in Rotary programs, meetings, and events is of paramount importance."
- "No in-person meeting or event shall be mandatory for any Rotary participant who may feel uncomfortable attending because of the pandemic."
- "All conveners and organizers of Rotary meetings are strongly encouraged to consider all health concerns in deciding whether to hold in-person meetings."
- "All conveners and organizers of Rotary meetings shall fully comply with all health and safety rules in effect in that location."

"Governors are strongly encouraged to use virtual meetings for club visits that occur during the calendar year 2020." I feel blessed that I was able to finish my visits in 2019!

Due to the staged approach to lifting the stay at home order in the State of Florida, I request that all Rotary Clubs continue to suspend in-person meetings through June 30, 2020. I do know about 2 very small clubs that have met, but are practing the recommended safe guidelines. Based on the above guidance, clubs are encouraged to suspend meetings in-person through the remainder of this calendar year. That is R.I.'s recommendation, but this decision will be made by your Board members under the guidance of in-coming Governor Jan Pooley. Clubs are required to follow local government health guidelines on in-person meetings and social distancing. Another factor to consider when resuming in-person meetings is that our liability insurance will probably not cover pandemic/communicable diseases upon renewal in July.

As it looks like we will be meeting virtually for some months, I encourage each clubs' Board of Directors to work with the club's venue and implement an appropriate adjustment to the dues structure to reflect changes in overhead costs.

It is fair to say that we will not return to our pre-Covid approach to Rotary meetings and events soon. Therefore, I ask all clubs to continue or establish routine regularly scheduled virtual meetings. Some clubs are currently doing this alone, while others are doing this as a group of clubs with one club being the host. Virtual meetings, while different from the usual for most clubs, offer some real advantages: reduced cost, no commute time, possibility of booking speakers from around the world, while maintaning connections with your Rotary friends. This reduced time and cost and enhanced flexibility should appeal to many that previously couldn't work Rotary into their schedules. Please schedule your virtual meetings and speakers for the next several months and invite potential Rotarians to your meetings. Let's Grow Rotary and offer the friendship, fellowship and magic of Rotary to our friends, family and colleagues.
