## President's Message

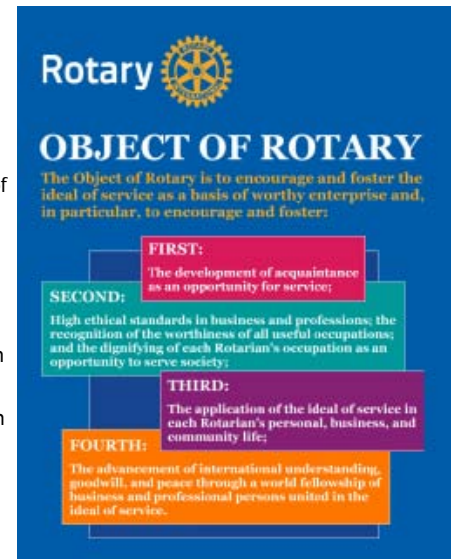
Each week we hang a banner of the Object of Rotary in our meeting room. Does anyone look at it or do we know what it means?
