These passionate Rotarians are always looking for a way to do more, to make a bigger impact on humanity. Enter our own Rotary Foundation, and Legacy Giving.

Not many Rotarians know that they can set up their very own Named Endowment Fund at The Rotary Foundation, The Jane and John Rotarian Endowment for (fill in this blank)♦ as an example. This fund uses its earnings to fund your passion. It can be set up to support one or more of our Seven Areas of Focus. It can be used to help fund Rotary Peace Centers. It can even be used as part of the SHARE program, where half the earnings come back to our District, and the other half goes to the World Fund

Pam and I have set up our Endowment to utilize the SHARE Program, so District 6960 receives additional funds each year to help with our club projects. That support does not end with our death, but continues, theoretically, forever.

Your Endowment can be set up with cash or one of many cash type vehicles (many of which have positive tax effects) of \$25K or more. It does not have to be all at once, it can be pledged over a three-year period. OR, Your Endowment can be set up through a Bequest of \$25K or more, that will activate upon your passing ♦ hopefully, many, many years from now.

This is a lot of information for a short blog, but The Rotary Foundation has people assigned to help you through every step. Many of you have met Debra Lowe, our Major Gifts Officer for Zone 34, and most of you know me. I serve as the Endowment and Major Gifts Advisor for Zone 34 and D6960.
