Judge John Kiener: A COLLECTION OF **◆FIRSTS◆** ABOUT WASHINGTON COUNTY◆S PLACE IN TENNESSEE◆S STATEHOOD

Tuesday, October 12, 2021



Judge John Kiener was born in Ft. Madison, Iowa, on June 21, 1940. He graduated from Loras College in 1962 and from Drake University's law school in 1965. Judge Kiener practiced law in Iowa and became an assistant attorney general for the state before relocating to Tennessee. Judge Kiener served as a city judge for Johnson City from 1975-1980 and then as Washington County's General Sessions Judge from 1980 until retiring in 2006. He also served as an adjunct professor at East Tennessee State University from 1975-2008. During his legal career and retirement, Judge Kiener contributed articles to both legal and genealogical professional journals. He also writes for the Jonesborough Herald and Tribune as an associate editor, serves as the Washington County Historian, and is a member of the Washington County Public Records Commission. In addition to his passion for genealogy and local history, Judge Kiener is a stamp collector and member of both the Rotary and Elks. He is a member of several genealogy societies and organizations. Judge Kiener is married to his wife Belinda and is the father of two daughters, Susan Lobsenz and Gretchen Lewis and three grandchildren.
