- Served from 1968-1971 in the U.S. Army.
- After the Army, attended college and graduated with Chemistry and Business degrees from the University of Maryland and University of Maryland University College.
- Married in 1975 to Gail (45 years) and worked from 1975-1983 in pharmaceuticals at Burton and Parsons and Alcon Laboratories.
- Relocated to Easton Maryland in 1983 and worked as the General Manager of Operations at Konsyl Pharmaceuticals. Promoted to VP of Operations and was trained in Marketing and Sales. Retired from Konsyl in 2018.
- Two sons Braden (wife Elissa) and Ronald (wife Meagan).



In other words, the actual date of your charter is September 1, 1921. However, all preliminary steps were taken in 1920.

Now about your question No. 2 as to whether or not Marlin Zimmerman should be considered as a past president of your club — gosh, about the only thing we can say is that this is something which you fellows in Easton can best decide. The fact that you tell us that the full membership of your club considered that he was actually promoted to the job of president, would seem to justify your classifying him as a past president, but again — this is something to be determined within your club. Wish we could give you a definite "yes", or "no" on this, Cal, but it really isn't for us to say.

# Many Cripples On Eastern Shore Are Given Aid By Dr. W. S. Baer

Hopkins Physician Prescribes Treatment For Those In Need As Part Of Work Conducted By Rotary Clubs-To Visit Other Towns.

pitals are few and great surgeons rare, hopelessly sick and crippled.

Recently he was in Easton. Before that he was in Salisbury. Soon he will go to other Eastern Shore towns, and the lame and the halt are waiting for him. He is Dr. W. S. Baer, of Johns Hopkins Hospital.

In Easton early this week 16 crippled boys and girls were examined by him. They were gathered together by the Easton Rotary Club, which makes its mission the effort to make the world happier for those who cannot move about and work like others.

#### Bought By Parents.

Bronzed farmers, with tears in their eyes, brought in their arms little sons and daughters with helpless legs, crooked backs and twisted arms-children who had been crippled since birth. Red Cross nurses carried some. Some came in wheel chairs or in the arms of their mothers.

Most of them made the trip to Emergency Hospital, in Easton, in the flivvers or in buggies of the farms-a trip most of them had never dared hope they would take.

Dectors and surgeons from all the country round about were gathered there to see Dr. Baer examine the children and to hear him diagnose the cases. He did not perform any operations, but road to normal health and activity.

On the Eastern Shore, where hos- he mapped out the roads to health and strength for each boy and girl. Most a "good angel" has been working for the of them, he said, could be made strong, active men and women, capable of working and supporting themselves and fami-

#### Outlines Treatment.


To the end that the work might begin. Dr. Baer outlined courses of treatment for each child, assigned them to hospitals or gave orders for proper care at home; prescribed the proper braces, pointed out the need of operations and arranged to have the operations performed. The Rotary Club will pay for it all.

Some will go to hospitals on the Eastern Shore, where facilities are adequate. Some will be brought to Baltimore hospitals. They ranged in age from 2 to 14 years at Easton, although three or four were men and women of 26 or 28. Most of them long ago had given up hope that they could be normal or their parents had given up hope for them.

#### Work At Salisbury.

Obstacles of the same sort-remoteness on little farms, lack of convenient transportation, lack of expert advice and lack of money-were overcome in another part of the Eastern Shore when Dr. Baer visited Salisbury.

There 95 crippled children and adults were brought to him through the efforts of the Rotary Club. They, too, were taken away already well started on the

In filling out an application for assistance for a new library, the preparer was temperarily stumped when he came to the section dealing with the environmental impact the new building would have on the existing animal population of the site.

The answer was as follows: "There are some ten to twenty squirrels living in the site proposed for the new library. Some trees that now provide either homes or exercise areas for the squirrels will be removed, but there appears to be ample other trees to serve these purposes. No major food source for the squirrels will be affected. It is likely that the squirrels will find no difficulty in adjusting to this intrusion. However, it will be difficult to tell if they're unhappy about having to find new trees to live in and sport about. Otherwise, no change in their behavior patterns is anticipated".


#### PROGRAMS FOR MARCH:


