Overview of the Rotary Foundation with Gary Dills



Gary is a native of Franklin, NC and resides in Otto, NC with Nancilee, his wife, a native of Lincolnton, NC. Both are active in the community, serving on various community boards and councils in Franklin and Macon County. The couple has three adult children and six grandchildren scattered along the east coast.

Mr. Dills retired as a Colonel in the United States Air Force with almost thirty years of active duty. He served in various senior command and staff positions at the Pentagon, European Command, Pacific Air Forces, and various installations around the world.

He commanded the 377 Air Base Wing at Kirkland AFB, NM, the 436th Support Group at Dover AFB, Delaware, and Air Forces (Forward) for Operation Uphold Democracy in Haiti. He is the recipient of numerous awards and decorations including the Defense Superior Service Medal, the Legion of Merit with two oak leaf clusters, and the Meritorious Service Medal with four oak leaf clusters. He is a master navigator with over 3000 flying hours in various aircraft.

He began his Rotary journey in 2006 and has served as Club President, District Finance Chair, District Foundation Chair, District Foundation Fund Raising Committee, and District Chair of Operation Renewal which assisted homeless veterans and their families. He was also the principal lead in establishing the Rotary Club of Clay County. He is one of the founders and active member of the READ2ME literacy project in Macon County and an active partner in the Dolly Parton Imagination Library for Macon County serving children from birth to age five.

Gary holds a Bachelor of Science degree in Chemistry from Western Carolina University, a Master of Science degree in human relations from Webster University and a Master of Arts degree in Strategic Studies from the Naval War College.

Update on In-Person Meeting Policy

A new order from the Buncombe County Board states that "face coverings are required of all Buncombe County citizens, residents and visitors in any indoor spaces in public spaces to maximize protection from the Delta variant and prevent possibly spreading it to others. Indoor public places means ... any indoor place the public is invited or allowed to enter and gather." The order also says, "for restaurants, bars, and other food establishments, this includes that all guests wear face coverings at their tables unless actively drinking or eating."

In order to comply with this order, our club **now requires that all meeting attendees continually wear a face covering** unless actively eating or drinking, regardless of vaccination status.
