### **District CART Update**

The end of 2021 is only eight weeks away, and Congress is debating a new, more expansive tax law. So now is an excellent time to consider tax-savings ideas that can reduce your taxes while supporting The CART Fund. Have you considered the following ideas:

#### Use your IRA as a Charitable Giving Account

For donors over 70 �, you can direct distributions from your IRA to The CART Fund without paying any taxes. If you take a Required Minimum Distribution (RMD), your direct gift will satisfy the IRS regulation that forces income and additional taxes you might not need.

#### 100% Tax Deduction ends on December 31, 2021

Donate cash in 2021, and you can use 100% of the contribution to reduce your adjusted gross income. The usual limitation is 60% but increased in response to the COVID outbreak in 2020 and extended to 2021. You can reduce your taxable income to zero. The gift must be an outright gift of cash to qualify for the increased deduction limits.
