


# **Spring Egg Hunt & Book Fair @ Rotary Centennial Park**

### **CALL TO ACTION for the LBRCF - March 27 Deadline!**

This is a call to action for nominations to the Board of Directors for the **Long Beach Rotary Charitable Foundation (LBRCF).** Historically, our membership has been modest in putting themselves forward for positions in the Rotary Club. Please note, self-nominations are not only okay but encouraged! See below for criteria for nominations and the process for selection of the new members.

Over the last few years your Rotary Club leadership has been making changes to policies, procedures, and By-laws to expand the opportunities of participation for all our members. The LBRCF Board of Directors, under the leadership of Matt Kinley, adopted amendments to the organization's By-laws to increase the number of members on the Board of Directors and how new members for the new seats on the Board are chosen.

For newer members, the LBRCF is a separate organization from the Rotary Club of Long Beach. It is a 501(c)(3) non-profit whose purpose is to receive and distribute funds in a manner that furthers the mission, projects and goals of the Rotary Club of Long Beach. Camp Enterprise, Reading by 9, Feeding the Future, and community grants, are all part of the funding through the LBRCF.

The LBRCF Board members consist of the Presidential line (president-designee, -nominee, -elect, current, and immediate past-president), as well as two members chosen annually by that year's president-elect who serve a three-year term. As a result of the By-laws change, two new categories of members were added to the LBRCF Board of Directors.

First, to facilitate participation in international projects the current and immediate past Directors of International Service from the Club's Board will also be a member of the LBRCF Board as long as they serve in that capacity.

Second, two members of the Rotary Club were added to the LBRCF Board for three years, bringing the total number to six "at-large†members. Each of these members will serve a two-year term. The basis for selection to fill these Board positions on the Charitable Foundation was adopted by the Rotary Club of Long Beach's Board of Directors. Below are the process and criteria for nominations and selections.

This is where you as a member of our Club can participate, by either nominating yourself, or another member (please ensure they would be willing to serve in the position if selected). **Nominations should be sent to Madrid** (madrid@rotarylongbeach.org) with a deadline of Wednesday, March 27<sup>th</sup>.

As adopted by the Rotary Club of Long Beach, the criteria for nomination and selection are as follows:

- Must be a member in good standing with the Rotary Club of Long Beach for three years or longer.
- Must have served in a leadership position, or had a significant role in a sanctioned project, of the Rotary Club of Long Beach.
- Must demonstrate a commitment to the values of the Rotary Club of Long Beach and be prepared to perform the duties of the Long Beach Rotary Charitable Foundation if selected.

The Board of Directors of the RCLB empowered the President's Council (president-designee, -nominee, -elect, current president and immediate past-president) to select two nominees from Rotary Club membership each year.

The process for selection is as follows:

- In March of each year a call for nominations will be made via the RotaryGram and at weekly Club meetings.
- In April of each year, the President's Council will review nominations and select two of the nominees to serve on the Board of the Long Beach Rotary Charitable Foundation for three years with their terms to begin in July, at the start of the Organization's fiscal year.
- The names of the selected individuals will be presented to the Board of Directors of the Rotary Club of Long Beach for approval at the May Board meeting.
