Join Randy Cohen, Vice President of Research for Americans for the Arts, as he presents the findings of the Arts and Economic Prosperity 6 (AEP6), a comprehensive economic impact study of the nonprofit arts and culture industry. Richard Lundin, is Managing Partner for Front Street Building Co. LLC. Richard has over 35 years of management experience as a business owner, commercial real estate financial analyst and accountant.

Richard formerly lived in Chicago and worked for his father in his auto body repair shop, helping to grow the business to include mechanical repairs, glass replacement and upholstery repairs. They then sold the business in 1999.

Taking advantage of his newly found free time, he returned to school to earn a BBA in finance as well as accounting at Loyola University Chicago. Upon graduation, he worked for Equities Realty, a boutique real estate firm that worked closely with the City of Chicago. One of his responsibilities was to analyze projects brought to the city seeking TIF funding.

Not being one to sit behind a desk he then built a real estate brokerage of his own specializing in finding distressed properties for clients and then handling the general contracting of the renovations to bring homes up-to-the-minute in design and functionality.
