Valerie Hepburn & Beth Byrnes
Insights on Development Trends, and work of the
DNR Marsh and Shoreline Protection





Dr. Hepburn serves on the all-volunteer Coastal Marshlands & Shore Protection Committees that review requested building permits and projects that could affect the shoreline or marsh. She gave us some history of protection policies. Georgia was a leading state in shore and marshland protection and the push came from Glynn County. The Coastal marshland Protection Act was passed in 1970 and permanently protected the marshes in southern Georgia. The bill was passed through the effort of Rep. Reid Harris with the support of the Garden Club

despite the opposition from the Chambers of Commerce, local government, and business leaders. The Shore Protection Act was passed about a decade later. She noted that the protection of the marshes helps protect us from sea level rise. The committee looks at the environmental, ecological, and wildlife effects when reviewing a proposal and the meetings are open to the public.

She also noted that erosion is a big problem and there needs to be a balance against the quality of the environment.

Beth is the Coastal Permit Coordinator with the DNR Coastal Resource Division. Her department reviews submitted plans looking to ensure there is no unreasonable harm to the environment, wildlife, etc. as well as considering the other public interests. There is usually a pre-application meeting where requirements are outlined and recommendations made. Her favorite part of her job is when she is out is the marsh looking at plants, tidal lines, and other indicators to determine marsh delineation. They also determine their shore jurisdiction based on high-water, sand dunes, and serviceable shoreline stabilization activity.
