March 6 Program – Michael Allen Morris Stafford County Deputy County Administrator

Our speaker, Michael Morris, described the development planned around Embrey Mill and the Stafford Hospital and Medical Center, developments that are grouped in a plan known as Destination Stafford. Destination Stafford is a vision in progress. First envisioned over 20 years ago, Destination Stafford is a multi-generational community development project. Destination Stafford is planned as a "place" to create a "community identity" for all of Stafford County. It is planned to be a versatile or adaptable destination to encourage entrepreneurial growth, create a vibrant cultural and commercial district, and combine diverse restaurants, retail, and a myriad housing options to call home. It is a broad area, a landscape or canvas outlined in the Comprehensive Plan that will encompass multiple neighborhoods and phases of development. This redevelopment area consists of roughly 840 parcels that contain approximately 1,743 acres of developable land. The project includes a mix of commercial

and retail businesses at the core, surrounded by residential choices. The Plan establishes the desired roadway network in the Courthouse Area, designed to provide a hierarchical system of interconnected streets.

The vision for Destination Stafford encompasses five goals that foster and create sustainable and healthy growth in Stafford County. The development of the County's property in Destination Stafford offers an opportunity to put these goals into action.



Destination Stafford will help alleviate the "retail gap" in Stafford and provide for new investments and create community gathering places. In 2018, Stafford engaged Stantec Consulting to recommend how the County's 23 acres may be developed as part of Destination Stafford. Those plans suggested 92,000 square feet of retail space. Stantec estimated a \$1.3 Billion retail gap in Stafford County. The market will determine the final mix, but the County's 23 acres in Destination Stafford further closes the retail "gap" in Stafford County.

Mr. Morris also discussed the impact of the newly approved Amazon data center. When completed this complex will generate \$350 million annually in local taxes.



Mr. Morris's presentation stimulated one of the longest question and answer sessions in our club's history. The importance of that "retail gap" was evident in the questions. Club members were especially interested in the new Buc-ee's that is scheduled to be built off of Exit 140, adjacent to Embrey Mill.

Other items of interest were:

- **❖** The location of the future new elementary school.
- Developments on Route 17.
- Aquia Town Center
- Replacement for the Regal Theater
- Roads for these developments?

 The County is working on Transportation Master Plan with the goal of making improved and additional north-south routes to avoid I-95. The cost will be shared by VDOT and the County. All the work on I-95 has been paid for by federal and a much smaller portion by state funding.
