District Grant Approvals

We have received preliminary approval for our two district grants submitted in May. There are a few more steps to finalize during the summer including RI input and approval. We expect to receive District Matching funds in the amount of up to \$4,000, which will become available in the fall. This will be split among two projects:

- 1. Educational student support program in Retalhuleu, Guatemala, allowing 20 students to continue education beyond elementary school. Club members may contribute individually to support additional children at a cost of \$200 per child annually.
- 2. Clean water filtration systems in Puerto Rico.

Importantly, this will be a rotary travel opportunity and the project work is scheduled for the week of March10, 2024 in coordination with Woodland Charities who successfully lead club projects in Guatemala for a number of years. Contact Tim Chesley or Linda Brown for additional information.
