PROGRAM

Our speaker was Stan Gedeon, owner of the Creekside Grill. Stan opened the grill in 2011, after several years of helping to design the building and the kitchen. He has several other kitchens, some serving disabled seniors.

His subject was tipping. He handed out a 5-page article on national tipping practices. Tipping is necessary to workers in the food industry, many of whom make minimum wage. A tip of 20 to 22% of the bill is the national average. Although you do not need to tip on the taxes, servers could see it as a cheapskate move if you don't. If you can afford it, it is kind to tip on the total with tax. If the server has to individualize the checks for many guests, an automatic gratuity is often added. It is a lot of work for the server to do 17 women, for example, for lunch, each with her own check. However, if a group just says divide bill by number of people, it is much easier for the server. The machine does that.

If you are at a bar, leave \$1 for a beer and \$2 for a cocktail. However, if you order a bar snack, tip 20%.

Other service providers should also be tipped it they provide a service, such as taxi drivers, hair dressers, tour guides, delivery people, and home service help such as caregivers. Also movers. 15 to 20 % of the total move cost is expected, and the amount split among the moving team.
