PROGRAM



The speaker at the meeting was Alyssa Stone, Director of Community Engagement from Joybound People and Pets. Alyssa works with the human bond to unleash the power to help and heal. Originally formed in 1991 by All Animal Rescue Foundation (AARF) and was renamed to Joybound. When one is asked what does the animal mean to you the unanimous answer is unconditional love. She reported that pets are important for those with post-traumatic stress and as we age, pets help people stay healthy. She stated that pets are medicine. Bringing animals to kids' lives is essential. Alyssa stated that they have about 850 volunteers which is the "life blood" of Joybound. Volunteers will socialize with cats and sit in condos with a dog during the day. They have programs that sponsor Pet Adoptions, Dog and Cat Training, Dog Grooming and Joybound transforms shelter dogs into psychiatric service dogs and trains shelter cats and dogs to become facility animals.
