#### Speaker for the Day — Ursula Jones Dickson

**Tricia Connors**, fresh off her trip to Portugal, introduced our speaker of the day, new member and Alameda County District Attorney, **Ursula Jones Dickson**.

Ms. Dixon is a dedicated and visionary leader committed to bringing justice with integrity, fairness, and transparency. With over two decades of legal experience, including her service as an Alameda County Superior Court Judge, and former Deputy District Attorney, D.A. Jones Dickson, brings a deep understanding of both the law and the communities it serves. Her appointment as District Attorney marks a return to principled prosecution rooted in accountability, public safety, and victim advocacy.

Since taking office, D.A. Jones Dickson has worked tirelessly to rebuild trust, enhance community engagement, and ensure that justice is applied equitably across Alameda County. Guided by compassion and driven by excellence, she is focused on smart reforms, strong partnerships with law enforcement, and a clear commitment to bringing and keeping our neighborhood safe while uplifting those most impacted by the justice system.

**Ursula Jones Dickson** sincerely thanked **President Joe** for inviting her and appreciated the warm introduction. She shared that today she intends to share a little bit about the DA's office and update the audience on the efforts to enhance community safety. She also wants to leave time for questions.

The DA began by sharing her mission. The mission is to ethically prosecute those who commit crimes. Uphold the rights of victims and provide them with compassionate support, as well as protect the communities that we serve. They also aim to collaborate with justice and community partners and foster policies that prioritize public safety and restore public trust. They'd like to reinforce innovative programs that provide opportunities for rehabilitation and reintegration, and to enhance the lives of the residents of Alameda County. The DA's office also has a mandate to represent the people of the State of California and always pursue the truth.

After a brief overview of the various branches and departments of the District Attorney's Office, Ms. Dickson provided a snapshot of accomplishments in her first 180 days in office.

- Focus on Survivors
  - We assisted 4,600 plus new victims, ensuring that survivors of crime had immediate access to counseling advocacy, as well as safety resources.

- We strengthened our community stakeholder engagement, so survivor voices were elevated through proactive outreach.
- Secured critical resources as grants were disappearing and dissipating from the federal and state levels.
- Advanced nonviolence and gun violence prevention, including AB 1344. A gun violence restraining order pilot program.
- Building a Stronger DA's Office
  - Restored Prosecutorial Capacity to Prosecutors
  - Deepened Community Engagement
  - Strengthened Infrastructure –filled leadership positions and managed budget process
  - Launched Organized Retail Theft Task Force
  - Reaffirmed Commitment to Fair and Equitable Justice
- What's Ahead Fair Charging and Safer Communities
  - o Initiate Hate Crimes Unit
  - o Restore Human Trafficking Focus, Wage Theft & Labor Affairs
  - Expanding Victims Witness Services
  - Strengthening Partnerships with Faith & Nonprofit Partners

The total number of referrals received has increased significantly with misdemeanor referrals over 8,000 and felonies over 3,500. The DA continues to rebuild community trust through town halls, listening sessions and conversations with local leaders.

DA Jones Dickson then answered questions from members and invited members to contact her office with further questions as her time was limited.

**Question:** I applaud the office for the support to victims families. Is that support still in place? **Answer:** yes.

Question: Is Alameda County, specifically Oakland, still the hub of the sex slave trade in CA.

**Answer:** Yes. International Boulevard and East 14<sup>th</sup> areas continue to be home to the sex trade. Need more tools to effectively deal with pimping and pandering as well as more officers.

**Question**: I've recently learned about Care Courts for the homeless population. What is the role of the DA's office? **Answer**: They do not have a role. They cannot refer to the Care Court. However, she does believe that it is a good resource.

**Question:** Casualties seem to be caused by guns in cars. Is there a role for gun checkpoints? **Answer:** Officers are not allowed to search in cars as they need justification. What is needed is more officers.

**Coach Joe** thanked **Ursula** for spending time with us and for her becoming a Rotarian. A contribution to Polio Plus has been made in her honor.
