#### Meeting Sponsor - Dan Cardenas - The Oakland Hills Campus

Today's sponsor was The Oakland Hills Campus, the new name of the former Holy Names University, that was acquired by BH Properties. **Dan Cardenas**, the Director of Campus Operations, told us about the Campus' features, which include a 389-seat theater, spacious class and conference rooms, a library, a first-rate basketball gym, and other facilities. The Campus, which occupies 60 acres, is set in the midst of landscaped open spaces that blend well with the surrounding woods. Although the new owner wishes to carry on the academic tradition of Holy Names, **Dan** said that only a portion of the Campus has been leased so far by academic tenants. So, they're now in the hunt for non-academic tenants, and, in particular, film production companies that can put the Campus to good use for movie scenes. To learn more, **Dan** invited us to attend a reception that will take place at the Campus on August 14 from 5:00 to 8:00 pm. The Campus will also be hosting a pediatric cancer fund-raiser for Stanford Medical Center at its theater on September 14. The Campus is located at 3500 Mountain Blvd, close to the Redwood Road exit off of the Highway 13 Freeway.

#### Thought for the Day - Moya Robinson

#### Speaker for the Day—Patti Poppe

**Sarah Chavez-Yoell** introduced our speaker, Patti Poppe, the CEO of Pacific Gas & Electric Corporation. PG&E is one of the largest investor-owned utilities in the U.S. as shown by its workforce of 23,000 employees who carry out its primary business—the transmission and delivery of energy. The company provides natural gas and electric service to approximately 16 million people throughout a 70,000-square-mile service area in northern and central California.

Ms. Poppe's upbeat theme was the California is a front-runner in the clean energy revolution and that the best way to put a big dent in the global warming crisis is to electrify the economy as much as possible, which means maximizing demand for electricity and expanding the generation/distribution infrastructure. She reminded us that the cost of electricity was very high at the outset of the industry but declined as more homes were connected to the grid and more electric appliances were produced. The same is true today and the foreseeable future: As the demand for electricity rises by electrifying more cars and other appliances, including heavy volume uses for data

centers and AI, this rising scale will yield lower per customer retail costs while generating more revenue for financing grid and other infrastructure expansion. Ms. Poppe declared that this is happening now and will accelerate. Thus far in 2025 electric rates have been holding flat, and she is confident that they will remain stable through 2030 and may in fact decline. The upshot is that "we can save the planet and save money at the same time."

PG&E has also been making headway with respect to safety. Ms. Poppe acknowledged that the company's power line undergrounding project is costly, but that the cost of conventional vegetation management (i.e. tree trimming and dry undergrowth removal) is significantly higher even with the efficiencies of using drones and Al. The company's upgrading initiatives have also made "brownout" rationing a thing of the past. Today, PG&E produces more power than we need. To illustrate her point, Ms. Poppe showed a picture of a large array of back-up storage batteries that occupy what used to be the Moss Landing natural gas driven power plant. More storage will become available when PG&E begins tapping into the excess power stored in electric car batteries. The company has also made significant progress in safeguarding its workers. When Ms. Poppe started in 2021, a work-related death occurred every few days. In contrast, there have been no fatalities over the last 896 days.

PG&E supports the continued reliance on nuclear power as a supplemental, carbon-free means of power generation. In fact, Ms. Poppe said that the Company is planning to apply for a new 20-year license for the Diablo Canyon plant.

Ms. Poppe received a loud ovation for her talk and was very grateful for the Polio-Plus donation that **Pres. Joe** said the Club will be making in her honor.



#### **New Member Induction – Marissa Betts**

Past President Jack McAboy sponsored and introduced our newest member, Marissa Betts, the granddaughter of members Past President Carla Betts and her late husband Ken Betts who together account for 83 years of club membership. Jack said Marissa is a star in the family business, having risen to the rank of Vice President of Ken Betts Inc. She has also starred as a Piedmont High School female rugby player and as a dazzling ballet dancer in Oakland Ballet's performance of the Nutcracker. With pleasure, Pres. Joe presented Marissa her new badge, pin, Four-Way Test, and other goodies including an Oakland Rotary cap. Welcome Marissa!
