# RCA By-Laws Change/Update--APPROVED!

The following change to our club's By-Laws was unanimously approved by members on Tuesday, 6/17/2025:

To strengthen RCA's leadership structure and develop a more effective continuity of leaders, the current Board of Directors proposes a By-Laws change to ARTICLE V – Election of President and Directors, Sections I – Nominations and 2 – Elections:

**Section 1**–Minimum qualifications for President-Designee ("**P-D**") shall be a member in good standing in the Rotary Club of Austin for at least five years by the time the P-D begins his/her term as President-Elect and served as an officer or director prior to their nomination.

The P-D elected in December of year one becomes the President-Nominee on July 1 of year two. After serving a year as President-Nominee, this person becomes the President-Elect on July 1 of year 3 and then becomes the President on July 1 of year four. The P-D automatically follows this cycle (Designee to Nominee to Elect to President) without additional elections required. The P-D will serve as a non-voting member of the Board.

**Section 2**–The date for the election of the P-D shall be determined by the Board of Directors...and shall not be later than the third meeting of the Club in December of the year before the year in which the President-Nominee will take office.
