February means Black History Month. Here is a statement from Rotary International:

At Rotary, we have no tolerance for racism. Promoting respect, celebrating diversity, demanding ethical leadership, and working tirelessly to advance peace are central tenets of our work.

We have more work to do to create more just, open and welcoming communities for all people.

We know there are no easy fixes and that challenging conversations and work lie before all of us. Rotary's strength has long been our ability and commitment to bringing people together. We will tap into that strength now as we stand with those who are working for peace and justice.

Rotary will do our part to listen, learn and take action to ensure that we continue to contribute to making positive change.

I found an **interesting article from the New York Times** last year that gives a brief chronological history of Black History Month.

I did not know that in 1926, Dr. Carter G. Woodson, father of Black History, announced the first Black History week in February of that year. In the second week of February, folks recognized both Abraham Lincoln's (February 12) and Frederick Douglass' (February 14) birthdays. Douglass Day had been celebrated in the Washington D.C. "colored schools" since 1897 because Douglass had worked with the school board there. Douglass had been born enslaved and therefore did not know what day he was born, so he picked February 14. In his book, *My Bondage and My Freedom*, Douglass recalled his last meeting with his mother, where she presented him with a cake. "*The 'sweet cake' my mother gave me was in the shape of a heart, with a rich, dark ring glazed upon the edge of it. I was victorious, and well off for the moment; prouder, on my mother's knee, than a king upon his throne,"* he wrote.

What did you learn about the history of Black History month that you didn't already know? What difference does that make?

Tomorrow we welcome Akoy Agau to the podium to talk about the Kentucky Distillers Basketball team. What could be better than talking basketball in February at Rotary? Well – you being in the room would top it off nicely!

# **Executive Director Update**

I have several important updates - and I'm putting them all in one post at the risk of you deciding "it's too long, I'm not gonna read all of that." PLEASE take a few minutes to scroll down. I would hate for you to be surprised by something down the road and feel like you weren't informed. Since this is longer than usual, I've left out several of the repeat announcements that have been in SPARKS for weeks - you can refer back to last week's email for that info.

#### CLUB ROSTER

It is out of my hands and at the printer...FINALLY. If there is one thing that made me question my decision over the past year to serve as your ED, it was this darn roster. It was a monster on my back. How can it be that big of a deal, you may wonder. Well, for a CPA who prefers relationships over minutiae but feels compelled to make sure things in print are \*perfect\* - and has insufficient time to devote to a project of this magnitude - it is a nightmare. More so because I know that as soon as it rolls off the printer it will be out of date.

My priorities since I dove headfirst into this role have been:

- 1. excellence in weekly meetings and the many other events I/we organize throughout the year
- learning all things Rotary (as a new Rotarian myself) the traditions and history of both Rotary International and our Club and Foundation, and the personalities and preferences of Club leaders - as well as acclimating to the world of nonprofit leadership
- 3. attracting guests and new members to the Club and creating a positive experience for current members
- 4. updating and automating processes related to Club and Fund finances to more efficiently utilize resources, minimize costs, monitor cash flow, and provide accurate and timely financial reporting,
- 5. enhancing and expanding the Club's visibility with media and in our community
- 6. strengthening communications so that members stay "in the know" about what is going on in our Club

Between the pandemic, the office losing two full-time employees in the same month, big new initiatives, and other challenges, simply keeping the "train on the tracks" (hi Charlie!) consumed all of my time. Knowing that the information was available in DaCdb to all members, the print roster took a back seat to bigger priorities. For those who rely heavily on it, I am sorry that you have not had this resource. Thank you for being patient.

Why did it take so long (for those who've questioned this)? I spent many hours obtaining more current, higher quality member headshots when possible and editing all to be of similar format with a transparent background. There were many inaccuracies and discrepancies in our DaCdb database - it clearly had not been kept up to date. I spent hours tracking down information about addresses, phone numbers and job changes. Very few people responded to my requests to submit updated information (thank you to those that did!), even though I knew what was on file was outdated. The classification system is no longer restricted to one member per classification as it was in years past. I see the primary use of that index in the back being a place to easily find members in a particular industry or organization to do business with, so I worked to simplify it and make it easier to find people, in addition to removing the listings for those who are retired. I "audited" all of the PHF and other recognition levels to match what was on file with Rotary International or in our documented records. I worked really hard to make this a great and accurate resource for you.

#### MEETING LOCATION

I'm pleased to report that the Board also voted to move our weekly meetings for the second quarter of 2023 to The Woman's Club at 1320 S. Fourth Street, beginning April 6th. This <u>historic venue</u>, constructed in 1923 specifically for The Woman's Club (founded in 1890), is a hidden gem; when the Board toured recently, many had not known it existed. Stay tuned for more information about this.

#### OFFICE SPACE

The Board also voted not to renew our office lease at Waterfront Plaza when it expires at the end of this month. Tracy and I have been working almost entirely from our homes, with the exception of going to the office once a week to pick up mail and print things for meetings. It simply does not make sense and is not good stewardship of our funds to continue to pay for office space downtown. Our Board

meetings will rotate to various member locations, and Walt, Tracy and I are happy to meet up with anyone at a coffee shop any time. We will have a physical address to receive mail and packages (stay tuned). We are hoping to make the furniture and office supplies available via auction to raise funds as part of our big upcoming FUNdraiser. Our Archives Committee, led by Stet Stetten and Tony Newberry, have been hard at work in partnership with the Filson Historical Society to determine the best options for preserving our Club's 110+ year history and to make it accessible to all members.

### ROTARY LOGO ITEMS

Several of you have asked about ordering items with the Rotary logo. I'm excited to report that a company I have worked with for many years has created an <u>online catalog</u> for us to order from. Feel free to look around and add things to your cart. All pricing includes the cost of embroidery but not sales tax. I will provide detailed instructions about how to order in a separate email.

### ROTARY FLAGS

If you have travel plans that would allow for a visit to a Rotary Club in the area(s) you will be staying, please request one of our Club banners/flags to take and exchange. I did so during my visit to my daughter in Spokane, Washington and now have good friends as a result. Make sure you get a photo and bring your flag to a meeting to present to our Club.

### ROTARY CONTRIBUTIONS

There is a program called *Every Rotarian*, *Every Year* - that many of the newer members have probably never heard of. Essentially, we ask each member to contribute (if possible):

1) \$100 each year to our local 501(c)3 Rotary Fund of Louisville, which funds our service projects and provides many grants in our community and beyond, and

2) \$100 each year to the international Rotary Foundation, which funds many of the programs Rotary supports including district matching grants, global grants, the eradication of polio and disaster relief.

We used to just add that on to the dues invoice and it was paid automatically by most members. Coming in with my CPA hat on, I changed things up, wanting to make sure that contributions were being made properly to the 501(c)3 foundation for purposes of claiming tax deductions. I also wanted to take advantage of lower credit card processing fees available to 501(c)3 entities. I urged everyone to set up those contributions directly, and some did, but the majority did not, to the detriment of both the Fund and the Rotary Foundation. I take that burden upon myself - it is my strong desire to rectify this in 2023.

So! Over the next few weeks, I am going to generate invoices from the Rotary Fund of Louisville for the \$100 Louisville Fund contribution and the \$100 Rotary Foundation contribution. *It is optional*; you are not required to pay these invoices. Just send me a note and I can easily void yours. You also do not have to pay the entire amount - you can pay \$25 per year if that's what fits your budget right now, or \$25 per quarter if you wish. I hope everyone will contribute SOMETHING. If you want to contribute more than the invoiced amount, you can certainly do so! You can pay by check or online with your credit card. If you normally make contributions from a donor-advised fund or IRA, just ignore the invoice if I forget and send one to you.

\*IF you want to take advantage of the District Matching Gifts Campaign (see post below) that runs from February 13 through March 26, where your donation of \$125 up to \$2,000 to The Rotary Foundation is matched with donated points to earn first-time or higher level Paul Harris Fellow recognition twice as fast - you can just give or mail me a check make payable to The Rotary Foundation and I will submit on your behalf. You must write "Annual Fund-SHARE" on the memo line, or leave it blank and I can write it in.

Finally, another project that I have been behind on for months is getting donor acknowledgment letters out. I am tackling that this weekend, but if you need yours before Monday, just email me.
