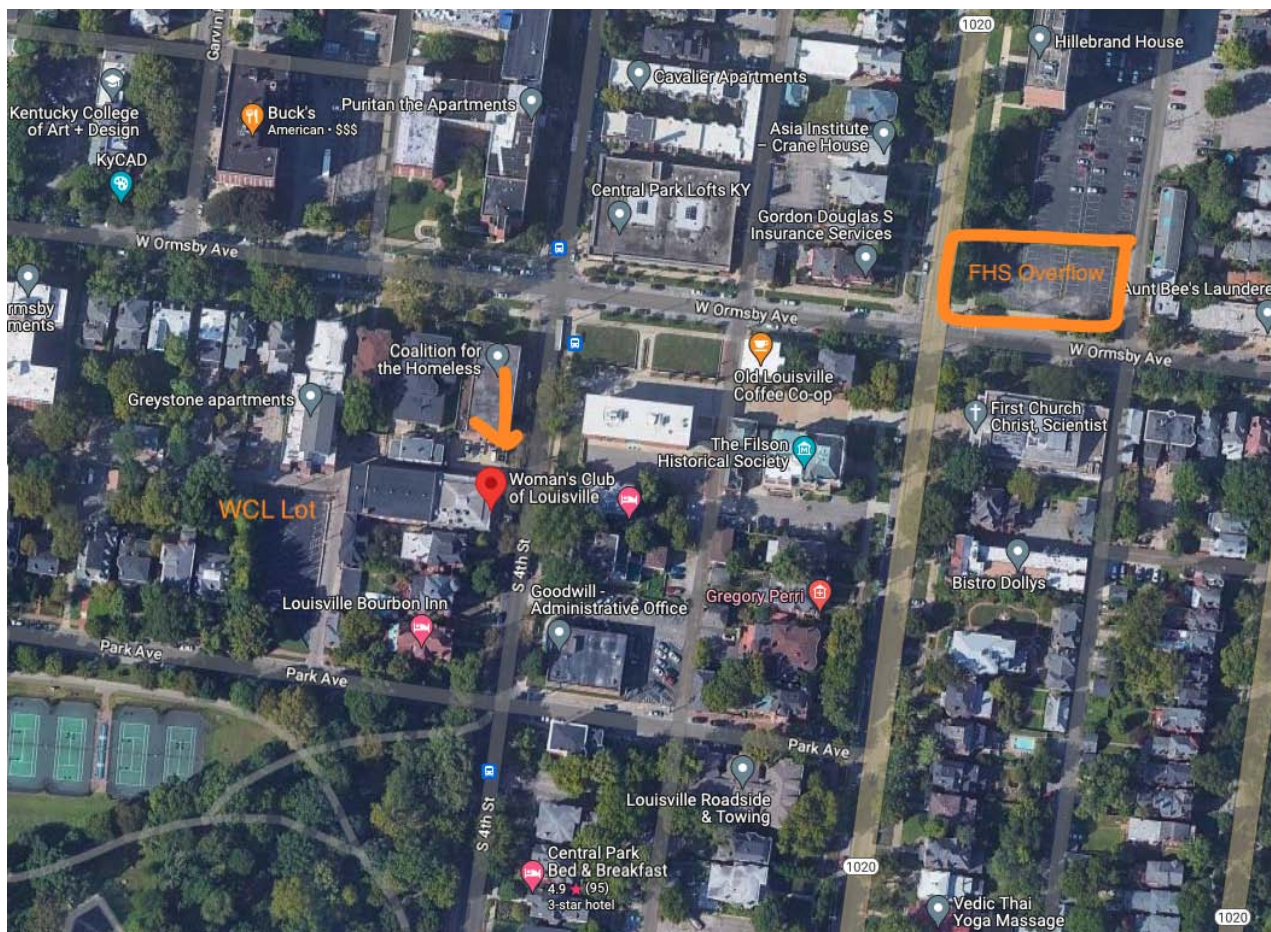

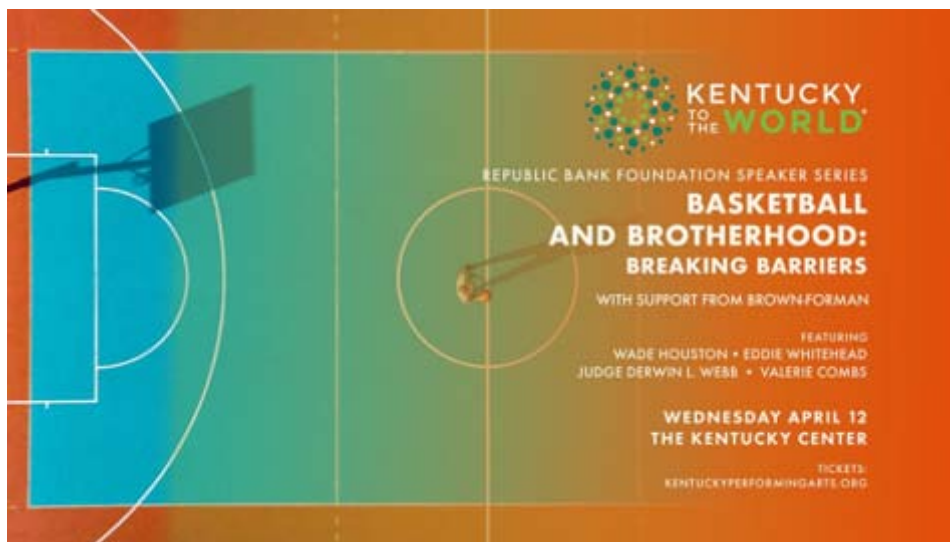

## Basketball and Brotherhood: Breaking Barriers



**What:** *Basketball and Brotherhood: Breaking Barriers*

**Organization:** Kentucky To the World

**Description:** This conversation will explore the barrier-breaking era of desegregation with former UofL athletes Wade Houston and Eddie Whitehead, who in 1962 paved the way for future athletes of color. The program will touch on how their struggles and triumphs went on to shape their lives. UofL Director of Development for Diversity and Engagement Valerie Combs, the first Black woman to sign a letter of intent to attend UofL on a basketball scholarship, and Judge Derwin Webb, a captain of the UofL basketball team who went on to become Kentucky's first African-American Family Court Judge, will round out the program. Clips from the upcoming documentary *Basketball and Brotherhood: Breaking Barriers*, produced by Jessica Loving, Luke Whitehead, and well-known Louisville filmmaker Fred Reynolds, will be interwoven throughout the special evening.
