

Denise Chaparteguy introduced our speaker, Tim Ricard who is the Sonoma County Cannabis Program Manager who is tasked with overseeing the multi-agency implementation of the Cannabis program and working closely with local cannabis businesses to help them navigate the often complex regulatory framework.



Tim brought over 15 years of economic development and urban planning experience to the position previously working for the cities of Livermore, Arroyo Grande and San Leandro. He received a bachelor of arts degree in history from the University of California at Santa Barbara and a master's degree in city and regional planning from Cal Poly San Luis Obispo.

It is estimated 70% of cannabis production leaves the state through the black market as it is illegal in most states in the U.S. Legislators are working on regulations and as Senator McGuire has said "we are building an airplane at the same time we are flying it." Trying to control cannabis is challenging our legislators due to the complexity of state versus federal regulations. And because they can't use federally insured banks the money laundering goes underground. The suggestion was made that banking be handled by the Native Americans because they are a sovereign nation. However, insurance becomes an issue.

Very interesting topic and his presentation was appreciated.
