

PASADENA ROTARY CLUB
CORPORATE MEMBERSHIP

Thank you for your interest in applying for a Corporate Membership with the Rotary Club of Pasadena. The phrase Corporate Membership applies to a Company, Small Business or Organization including Non-Profit Organizations.

In accordance with Rotary International, memberships are set up under the name of individuals. Therefore, Rotary Club of Pasadena will set up Corporate Members, but it will be under the name of the lead person as determined by the member.

Key Membership Criteria

- Your corporation or organization will have one primary and up to three Corporate Alternate members;
- The primary member and their organization will participate in a screening process to ensure an appropriate ‘fit’ between the prospective member organization and Pasadena Rotary. Associate members will be selected by the primary member.
- Your corporation will be able to replace members as needed.
- Should a primary or associate member leave your corporation, the member may join the Club as an individual member.
- Under a Corporate Membership, more than one member of the corporate entity can attend a meeting. One attendee is covered under the membership and additional attendees will pay \$45.00 to attend. The additional \$45.00 is added to the monthly invoice.
- The one-time initiation fee for Corporate Members is \$250.00.

Here is how to apply for membership with the Rotary Club of Pasadena.

Let your sponsor know and they can help you through the process. If you don't have a sponsor, contact Past President Howard Raff, Membership Chair at howard.raff@lpl.com or 626-712-4920, and he will help you through the process and serve as your sponsor.

To start the process – go to www.pasadenarotary.com. Click JOIN TODAY tab then click on Member Application. Fill out the Membership Application and click “Submit Member Proposal Form”. The data you enter will be used by Pasadena Rotary, Rotary District 5300, and Rotary International. Submit your Corporate Alternate Members in the same manner.

We will contact you when we receive your application to confirm.

Your Sponsor will submit a letter of recommendation for you to the Pasadena Rotary Board of Directors. Your application plus the letter of recommendation go to the Board of Directors for approval (the board meets the 3rd Thursday of each month).

After Board approval, your request for membership is published in our weekly newsletter SPOKES (which goes out every Friday morning). This allows for a 7-day notice period for the general membership. If there are no objections from the general membership during this 7-day period, you will be inducted at the Wednesday meeting of your choice

All new members become TYRO Members for a year and meet monthly along with TYRO Committee Members and Committee chairs to learn more about the club and establish strong relationships with other TYRO Members. Currently TYRO meetings are held at El Torito Restaurant, 3333 E. Foothill Blvd. Pasadena. Meal cost is billed to the monthly invoice.
