Assemblymember Chris Holden brings to the legislature a lifetime of experience in public service and business garnered during his many years on the Pasadena City Council and the Burbank-Glendale-Pasadena Airport Authority.

He was first elected in 2012 to represent the 41<sup>st</sup> Assembly District from Pasadena in the West to Upland in the East and

includes the communities of Altadena, Claremont, La Verne, Monrovia, Rancho Cucamonga, San Dimas, Sierra Madre, and South Pasadena.

Assemblymember Holden currently chairs the Assembly Committee on Utilities and Energy, and the Select Committee on Regional Transportation Solutions.

Throughout his time in the legislature, he has worked to grow our economy, protect our environment, and strengthen our infrastructure and support working families.

This year, Assemblymember Holden established a \$50 million dollar increase in the State budget for Developmental Disability Services to serve individuals and families living with disabilities including autism, Down syndrome, cerebral palsy, and intellectual disabilities.
