# How We Serve Our Community and the World

Your rising professionals will join our club members, families, and friends serving our community in a wide variety of activities that can also lead to leadership opportunities, including:

- Support of Rotary International in partnership with the William and Melinda Gates Foundation to eradicate polio.
- Support Rotary International to provide clean water in under-developed countries, enhance literacy, prevent disease and engage in peacemaking.
- Lead and participate in grants for community improvement projects.
- Provide literacy assistance in the Orange County Public Schools through the purchase of dictionaries and the distribution to third grade students in elementary schools serving Winter Park students.
- Sponsor outbound and host inbound Rotary International Exchange Students.
- Grant and distribute college scholarships to local students seeking higher education.
- Sponsor local high school students for Rotary Youth Leadership Awards (RYLA) to develop leadership skills in young people.
- Sponsor local young professionals for cultural exchanges with other countries.
- Partner with the Salvation Army for the annual Christmas Bell Ringing Program in Winter Park.
- Collect food for Killarney Elementary School and Winter Park High School food pantries throughout the year for underserved school children.

## Benefits of the Corporate Membership Program

- Your company will be provided with three (3) memberships; one (1) primary and two (2) associate members.
- Your corporate members will receive name badges that will include the member's name as well as the name of your company.
- Corporate membership provides opportunities for community engagement with other professionals and business leaders in Winter Park.
- The primary member will receive full membership in The Rotary Club of Winter Park, including full participation in all club activities, full voting rights, and the ability to hold leadership positions within the club. Associate members will have full privileges but not voting rights.
- Your company's logo will be displayed on The Rotary Club of Winter Park website, and in our weekly e-Newsletter, Spoke 'n' Wheel. Your logo will include a link to allow readers to go directly to your web site.
- Your company can advertise in our weekly Spoke 'n' Wheel once a year at no charge. You may sponsor additional weekly e-newsletters for \$100 per week.
- Once a year your company will be designated a meeting sponsor. You will be provided with a table to display and distribute your corporate information and will be given three (3) minutes to show a PowerPoint presentation to provide information about your business prior to the weekly meeting.
- Your company will be able to display the Rotary logo and the Rotary International Four Way Test in your place(s) of business, website and stationery.
- Your company will be provided with a Certificate of Membership suitable for framing.
- Your team members will learn about the Winter Park and Central Florida community through our weekly programs while building collegial relationships and contacts with many business leaders.

# Application Process

1. Club members identify prospective corporate members and submit their recommendations by using the Proposal for Corporate Membership form.
2. The Proposal will be sent to the Membership Committee for review and assignment of a Classification.
3. Once approved, a formal invitation to join The Rotary Club of Winter Park will be extended to your company's leadership by the Club President and the Membership Committee.
4. Upon payment of the application fee and dues, along with the submission of personal data about the three (3) corporate representatives, one (1) Primary and two (2) Associates, an invitation will be extended to attend a Fireside Chat.
5. After attending the Fireside Chat, the corporate representatives will be introduced and formally inducted into the club.
6. The club membership remains with the company, but the company may choose to change representative club members at any time by notifying The Rotary Club of Winter Park.

### CORPORATE FINANCIAL COMMITMENTS:

1. Fees for three representatives is \$850.00 annually plus an initiation fee of \$150.
2. The Primary member and the two Associate representatives will be charged the normal luncheon/meeting fee per person per visit.

### MEMBER PARTICIPATION:

Corporate members are encouraged to attend all club activities, including the weekly meetings held each Monday at noon to 1:15 pm at the Woman's Club, 419 S. Interlachen Avenue Winter Park, FL 32789, in Downtown Winter Park. While attendance is not mandatory, a member will not realize the full benefit of the club if attendance is irregular. We encourage everyone to attend as regularly as possible.
