## FREQUENTLY ASKED QUESTIONS

#### WHAT IS THE CANSTRUCTION PHENOMENON?

Canstruction is an exhibition of structures made from unopened cans and other non-perishable staple foods that after the event are donated to organizations fighting food insecurity. Canstruction unites participants by using their creativity to create a meaningful temporary sculpture of non-perishable food items. It is functional art that brings team members together in collaboration for a greater good.

#### WHAT IS THE BENEFIT FOR MY COMPANY?

**Sponsorship** – The Canstruction challenge is a great opportunity to create team building, motivation and collaboration, encourage philanthropy within our local community, create a greater awareness of community relations, and showcase your company's involvement to benefit our shared community. Submissions will be built in the Galleria Mall, where they will be on display for 2 weeks for mall visitors to view. Video submissions for our awards ceremony can be shared on social media for publicity. Awards in various categories will be announced at our Gala.

#### WHAT IS THE SCHEDULE FOR THE CELEBRATION?

The elegant evening will feature a cocktail reception that allows guests to peruse and bid on silent auction items and preview the live auction. The event will feature an exquisite party, live auction, and an awards ceremony for the Canstruction contributors.
