# Membership Categories, Dues & Fees







### **Regular Membership**

A Full Active Member is expected to attend regular meetings and become fully engaged in giving service to communities; both locally and abroad. A Full Active Member is encouraged to suggest new project ideas. The Full Active Member may vote on all club resolutions and elections. Full Active Members are expected to attend 60% of all

regular meetings at this club or another Rotary club. Please refer to our website under the Rotary & District Links section for Where

## **New Generation Membership**

A Full Active Member who has not yet reached the age of 35 years old may apply to be a New Generation Member which exempts him/her from the attendance requirement.

### **Corporate Membership**

Rotary membership is only open to individuals and not corporations. However, to best describe this membership category it is named a Corporate Membership. This membership enables a senior business leader of a corporation, limited liability company, and/or limited partnership to join as a Full Active Member and up to three specific designees from his/her corporation to attend all club meetings, social functions, service projects, and participate in fund raising activities. Only the Full Active Member can vote on club resolutions and elections.

## **Family Membership**

This membership enables a spouse/partner or a parent/child of a Full Active Member to become a Full Active Member of the club, at a cost lower than twice the Regular Membership dues.



### **Rule of 85 Membership**

A Rule of 85 Member is a Full Active Member who is exempt from the attendance requirement. To apply for Rule of 85 membership, the member's age plus years of Rotary membership must add up to at least 85.

### **Honorary Membership**

An Honorary Member may be elected by the Board at any time and continuing membership must be renewed annually at the July board meeting. An Honorary Member does not pay Membership Dues, is exempt from the attendance requirement, and cannot vote for any resolutions or election.
