Copyright © 2024 Rotary District 7610 All Rights Reserved As the weather warms up and we head outdoors more often, getting a breath of fresh air to clear our heads, and encouraging kids to get some vitamin D and exercise, it seems appropriate that May is both National Mental Health Awareness Month and Rotary's Youth Services Month. From the moment RI President Gordon McInally first introduced a global initiative for members to reduce the stigma surrounding mental health, clubs and districts across the globe



have taken up the cause, benefiting mental health programs and projects through district grants and global grants that fill gaps in communities worldwide. Some efforts provide for the general public, but many address the needs of our youth, creating or supporting programs that provide the services and resources many families cannot otherwise access.

Prior to this Rotary year, many clubs in our own district were already involved in projects serving youth or that incorporated mental health aspects, but we've also seem positive and promising growth, and even projects that encompass both youth and their mental health. I feel it's important to mention a key reminder here that The Rotary Foundation provides the funding for these projects through District, Global, and Scholarship grants, and requires all clubs participating in projects funded by these grants that involve working with youth, to have a Youth Protection Policy and Procedure Guide. The funding for grants provided to the Mathews, Rosslyn-Fort Myers, and Manassas RCs for each of their education projects, funding for the health services for marginalized families being supported by the Herndon-Reston RC, and funding for the clothing program aided by Bull Run RC for children in need, comes directly from a percentage of the contributions made by individuals and clubs in our district three years ago, to The Rotary Foundation (TRF). The value of investing in our global community through TRF, has the added benefit of always seeing a percentage reinvested in the local region as well, and that figure is increased through required participating club investment, through the District Grant program.

If we want to continue to see new and innovative grant projects that are approaching local and global challenges with creative and efficient solutions, we need to make sure the funding is secure and will continue to maintain a pace capable of keeping up with the needs of the communities we serve. What does that look like? Purposeful contributions to our own organization. Our Foundation is a non-profit that lets us, as donors, choose exactly how funding is applied, and then activate that funding through grants that produce projects. Some of those we bring to life with our own hands. As we approach the end of the Rotary year I ask you to appeal to your board or charitable decision-making committee, to consider adding The Rotary Foundation to the list of organizations your club supports, and to encourage fellow members in your club to consider the same. After all, we are people of action, let's take action to support The Rotary Foundation and bring our projects to life!

#### **Everything Begins with a First-Step!**

Donating to Our Rotary Foundation (The Rotary Foundation, TRF) is a fundamental expectation of Rotarians. Accordingly, Our Rotary Foundation does a very good job in encouraging and recognizing members that become Paul Harris Society members, giving \$1000 annually, and additional recognition for those that donate at higher levels.

However, all giving begins earlier than the PHS levels. It generally starts with an expected, reasonable, doable entry level of giving. So, it is important that we appreciate that annual donations of under \$1000 comprise approximately 50% of all annual donations to TRF from Rotarians across the world.

To assure Our Rotary Foundation of the tomorrow, we need all members donating to The Rotary Foundation at some level. Hence, The First-Steps of Giving program expects that all new members and those new to donating to TRF will give at least \$10/month through Rotary Direct, recurring giving. \$10 is the minimum amount the program can allow members to set up their monthly giving program.

Also, as part of this First-Steps program, we're asking that the traditional Sustaining member donation level of \$100 be raised to \$120. This increase puts it on par with the First-Steps program, and if paid quarterly, going from \$25 to \$30 per quarter.

## Your Report from the PolioPlus Corner

<u>2024 Polio Case Totals.</u> The chart below shows current 2024 case totals for wild polio and vaccine-derived polio. The 4 wild polio cases all occurred in the usual contiguous Pakistan/Afghanistan area. The 27 vaccine-derived cases compare favorably to the 62 cases at this same time last year.

Saudi Arabia Financial Commitment. The Kingdom of Saudi Arabia has pledged a total of US\$ 500 million over the next five years to support the work of the Global Polio Eradication Initiative (GPEI). This announcement marks a significant increase in funding for the global effort to eradicate polio, enabling GPEI to protect more than 370 million children with polio vaccines every year while strengthening health systems to better prepare countries for emerging health threats.

Death of Polio Eradication Advocate PRIP Herb Brown. Herbert G. "Herb" Brown, the 1995-96 president of Rotary International who met with world leaders to advocate for polio vaccination and helped raise millions of dollars to fight the disease, died on April 23 at age 100. Brown was a tireless advocate for polio eradication, serving as chair of the U.S. PolioPlus Campaign Committee in 1987-91. He played a pivotal role in raising over US\$125 million in the United States and more than US\$240 million worldwide to help immunize children against the disease. He met with South African President Nelson Mandela shortly before Africa launched the Kick Polio Out of Africa campaign and met with leaders in India before the country agreed to undertake National Immunization Days.

**Minda Dentler—Not Just a Survivor.** Minda Dentler is a remarkable polio survivor who is the first female wheelchair athlete to complete the world's toughest triathlon-The Ironman World Championship. An author, mom, and force to be reckoned with, Dentler has never stopped promoting polio immunization at Rotary and other functions throughout the world. From speaking at our own Rotary

constant inspiration in the fight to eradicate polio. Drawing from her personal journey of contracting polio as a child prior to the widespread availability of polio vaccines in India, Dentler frequently highlights the remarkable success of eliminating polio within that country. She urges global leaders to continue to learn from India's strategies, to reach every child with a polio vaccine.

#### Special message from DRFC Pat Borowski and PHS chair Ronnie Chantker

Rotary District 7610's Foundation team is promoting a new Initiative, The Paul Harris Points Use Program. In the past, clubs have been encouraged to use their Paul Harris Points to create a Paul Harris Fellow and recognize a member, community leader, or outstanding Interact Student, however, this initiative is to encourage clubs to use Paul Harris points to develop new Club Leaders.

Clubs are encouraged to have their new members or members who do not contribute to The Rotary Foundation become a contributor to The Rotary Foundation before they can become an officer in their club.

How can this be accomplished? Encourage your member to participate in Rotary Direct and donate at least \$10 a month. At the end of a year they will have donated \$120, which can become the new "Sustaining Member" amount. Once the year is completed, you can offer matching points if the member raises their contribution by \$5 -\$10. They will be on their way to becoming a Paul Harris Fellow. This method is the "First Steps of Giving"

Another option is to offer points to a member who has not yet donated by asking them to begin a regular donation of \$100 a month through Rotary Direct, or an immediate donation of \$100 followed by enrollment in the Rotary Direct Program. Of course, other matches could be made depending on the amount of the donation to The Rotary Foundation.

Your Rotary Club will need to appoint someone on their Club Rotary Foundation committee to keep track of the members donations and points received.

We will be working with your Club Rotary Foundation Chair in continuing to develop this new Club Leader Paul Harris Fellow Program and the new additional "First Steps of Giving".

As RY2023-24 draws to a close, we are beginning to see more members who qualify for recognition as Major Donors. Recently, we have noticed that there is some confusion with respect to how to recognize these members. The process RI wants the Districts to follow has been changed. In the past, RI would notify the District which, in turn, would notify the Club President. The President would then contact the member and ask him or her to decide where they should be recognized and what materials they would like to receive, pin or lavalier and crystal. Now, RI sends the information directly to the member who responds to RI and then tells the club how they wish to be recognized. The District feels that new and higher level MDs should be recognized at a Club level ceremony. The DRFC and/or the Major Donor officer may be invited to attend this recognition. In any case, all new Major Donors and new recognition levels 2-4 will be acknowledged, by name, in November at the annual Foundation event. If an MD wishes to have the entire ceremony in November or wants opt out of recognition ceremonies, that is their prerogative.
