Our community has rising case of kidney failures which calls for Hameo Dialysis, depending on the severity of the failure , frequency of the dialysis is decided and patient has to undergo dialysis as recommended by the doctor, which is a long and costly affair and sometimes patients do not have dialysis facility in the near by vicinity and also the process is a costly affair which drains the family economically , so because of lack of enough dialysis facility and economic condition patients do not take sufficient dialysis and suffer and sometimes die prematurely

How did your project team identify these needs?

visiting various hospitals in rural and urban areas it was found that

1. The rise in numbers of patient with kidney ailments and frequent dialysis were required to be done
2. Because of insufficient numbers of dialysis machine the patient had to wait a long for their turn and sometimes the wait exceeded the recommended frequency.
3. The distance from home to health center was another problem the patient has to face and also pay extra for the transportation.
4. Patients had to pay higher fees at private facility which is not affordable to many patients and so they stop taking dialysis and suffer and eventually meet untimely death

How were members of the benefiting community involved in finding solutions?

Local community help in many ways as under

1. Help upgrading or augmenting current facility or creating one by providing space, and other infrastructure
2. Some Volunteer at the center by providing food, transportation , and comfort patient and their relatives
3. Some help by contributing for operating cost so that patients dont have to bear any cost for the treatment

Need were identified based on the need assessment and also request of hospital for machines were considered, more over visit to hospital to cross check the need, visit to present dialysis machine center and noting the waiting list and observing patients waiting for their turn for dialysis as per the frequency recommended by the doctor and it was observed that many patients had to wait for longer period than recommended and looking to the rise in the patients need was felt to go for additional machines as well as new center
