

PROGRAM LAST WEEK by Jeff Baumgardner



Last week's speakers were Richard Holley and Cindy Meares with Cherry Bekaert. Cherry Bekaert specializes in tax, audit and advisory services. Both Richard and Cindy are CPAs. Their topic of discussion was "What You Need to Know Now". Richard let us know that we/they are now dealing with the largest tax overhaul since 1986. Richard focused on the effects of the tax code changes on the individual side while Cindy highlighted some of the business changes that are going into effect. Cindy mentioned that the new tax code is over 1000 pages long and that further clarification is coming as to how all of this is to be interpreted and applied going forward. On the

individual side Richard pointed out that in general there were "Winners and Losers". Richard listed under the Loser category "Dinks" (Double Income No Kids) and possibly the Upper Middle Class. Winners with the tax code changes may be considered the "Married With Children" filing status. On the business side Cindy stated that the changes should be good for small businesses. Both speakers touched on a number of changes that most likely will affect the vast majority of us Rotarians. My take away was you have to be proactive, it is virtually impossible to know how all of this will affect you and most importantly you need to have a knowledgeable and trusted CPA to lead you through all of these changes. Nothing is more expensive than ignorance.
