- ✓ For contributions from Business/Family Charitable Organizations, please use only cheque.
- ✓ PAN of Remitter is mandatory.

Individual Virtual Account



A contribution channel that allows donors to make NEFT/RTGS payments towards Annual Fund & PolioPlus Fund of Rotary Foundation (India)



Step-1

Add Beneficiary Name:
Enter beneficiary name as
Rotary Foundation (India)



Step-2

Add Beneficiary Account Details



Step-3

Beneficiary Account Number will be:
ROTARYIN(followed by Remitter's complete PAN number)(followed by Remitter's Rotary ID)(APF/POLIO)



Step-4

Enter the following details:
Account Type: SAVING
Branch's IFSC Code: HSBC0110002
Save Nick name as: APF/POLIO RFI

For example, if the Remitter is KAMAL KUMAR whose PAN number is ABCDK4578P, his Rotary ID is 12345678 and the remitter wishes to contribute towards Annual Fund, then the BENEFICIARY ACCOUNT NUMBER will be **ROTARYINABCDK4578P12345678APF**

Key Points To Note

- ✓ This channel is currently available for Annual Fund & PolioPlus contributions only.
- ✓ In case Rotary ID is less than 8 digits, please prefix with 0. For example, if ID is 123456; please mention Rotary ID as "00123456".
- ✓ In case the information such as Rotary ID and the name of remitter does not match with Rotary database, a refund will be generated by Rotary Foundation (India).
- ✓ The payment should be made from remitter's own individual account and not from his/her spouse or family member's or club member's bank account.
- ✓ The remitter must ensure entering correct PAN number as the PAN number once entered cannot be modified. It also helps generate an accurate 80G certificate.
- ✓ To avail this option, donor needs to have Net Banking facility in his/her bank account.
