# ROTARY CLUB OF ISSAQUAH 2024 COMMUNITY SERVICE GRANT PROGRAM <u>FREQUENTLY ASKED QUESTIONS</u>

## Q1. What is the timeline for the application and awards process?

April 1-30 Grant application period open.May 1-12 Grant application review and evaluation.May 13-17 Notify recipients of award.May 21, May 28, or June 4 \*Grant recipients receive awards at club meeting.

\*We require that all grant awards be made via a formal in person presentation of a check to the selected organizations at either one of these Rotary club meeting dates.

# Q2. How will my grant application be reviewed and evaluated? The following criteria will be used:

### Grant Guidelines

1) Community Obsession – serving our community to the best of our ability:

Projects will be evaluated based on their impact on the local community and the extent to which they address the community's specific needs and aspirations. Evaluation criteria may include:

Measurable improvements in the well-being, quality of life, or access to essential services within the community.

Demonstrated engagement and collaboration with community members, ensuring their active participation in project planning and execution.

Evidence of responsiveness to changing community needs and the flexibility to adapt project strategies accordingly.

2) Youth Empowerment and Leadership – guide and mentor our youth to become our future leaders:

Projects focusing on youth empowerment and leadership development will be assessed based on their effectiveness in nurturing the potential of young individuals. Evaluation criteria may include:

The acquisition of leadership skills, knowledge, and personal growth among participating youth. Evidence of mentorship and guidance provided to young participants, fostering their personal and professional development.

Sustainable outcomes that demonstrate how the project contributes to youth becoming active and engaged community leaders.

3) *Environmental* – enhance and preserve our beautiful Issaquah:

For environmental projects, the evaluation process will focus on their contributions to the preservation and enhancement of the local environment. Evaluation criteria may include:

Measurable improvements in environmental quality, such as air and water quality, green spaces, or biodiversity.

Sustainable practices and long-term benefits, demonstrating a commitment to preserving Issaquah's natural beauty.

The level of community involvement in environmental conservation efforts and the promotion of environmentally responsible behavior.

# Q3: Who is eligible to apply for these grants?

Eligibility criteria may vary depending on the specific grant, but generally, local non-profit organizations, community groups, and initiatives aligned with our mission are encouraged to apply. Locally based non-profit groups, schools, churches, and other locally based charitable organizations are eligible. Applicants must be organizations that serve youth and their families residing within the Greater Issaquah Community and within the boundaries of the Issaquah School District. (The Issaquah School District spans 110 square miles, supporting approximately 19,000 students living within the cities of Issaquah, Newcastle, Renton, Bellevue, and Sammamish).

# Q4: How can I apply for a grant?

The initial grant application process is open <u>April 1-30, 2024</u>. <u>Deadline is Tuesday, April 30,</u> <u>2024 at 12:00 midnight PST.</u> To apply, you will need to complete and submit the application form during the designated application period. # Deadline: All applications must be received no later than Tuesday, April 30, 2024, at 12:00 midnight PST.

## Q4: What is the evaluation process like for grant applications?

Grant applications are rigorously reviewed and evaluated based on specific criteria related to the grant's focus area(s). The Rotary Club of Issaquah Community Service Committee is responsible for review and evaluation of all applications. This evaluation process ensures that grants are awarded to projects with the greatest potential to make a meaningful impact in our community.

### Q5: When will I know if my organization has been awarded a grant?

Grant recipients will be notified of the awards during the notification period, which typically occurs after the application review and evaluation phase. You can expect to receive a notification via email regarding the status of your application during this time.

### Q6: How will the grants be awarded?

Grant recipients will receive their awards during a special presentation at a Rotary club meeting. This presentation includes the awarding of a check to the organization.

# Q7: Are there any expectations for grant recipients after receiving an award?

Yes, grant recipients are expected to deliver a speech or presentation during a Rotary meeting or event sometime in the following year. This presentation provides an opportunity to share the results and impact of the project with the Rotary community. By December 31, 2024, grantee will provide a summary on how the grant award was effectively used that year including any statistical information on the number of students or families benefitted from the award along with any other relevant information that would make illustrate the impact of the work of your organization.

We ask that you recognize and acknowledge the Rotary Club of Issaquah for your grant. This may be through the authorized use of our club logo on your website and/or organization's

marketing collateral, print or digital newsletter, social media, or other platforms to allow increased visibility for both of our organizations. We reserve the right to use photos and/or testimonials either in written or video form from your project on our website.

As a grant applicant, you will have the unique advantage of tapping into Rotary's extensive network, resources, and expertise. If you had applied for a grant during a previous grant application period and had not received a grant, you may reapply. If you received a grant award during a previous grant application period and did not receive the full amount of the requested grant, you may reapply for the balance of the amount.
