The Birth of The Rotary Foundation



Arch C. Klumph

- Born: 1869
- Charter member of the RC of Cleveland in 1911
- 6th President of Rotary International.
- Involved in writing the constitution of Rotary.
- Rotary Districts, District Governor and District Conferences.
- Suggests Rotary start an endowment.



"doing good in the world" but a bit slowly...

- Arch Klumph proposed it in 1917, the RI Board approved it but didn't approve a mechanism to fund it.
- For 10 years Rotary leaders went along with it but with little action or enthusiasm.
- In 1928, name is changed to The Rotary Foundation

Rotary Foundation Milestones

The Foundation's first grant was made in 1930 for \$500 and benefited the "Crippled Children Societies" – a precursor of Easter Seals.

In 1947 - unprecedented flood of contributions, providing the basis for the first Foundation program known as: "Fellowship for Advanced Study"



Rotary Foundation Milestones

- 1957: Paul Harris Fellow designation created
- 1978: First Health, Hunger and Humanity Grants (3-H). First 3-H grant project immunized 6 million children against Polio in the Philippines
- 1982: Permanent Fund is established
- 1985: Foundation initiated PolioPlus
- 1999: Bequest Society established for commitments of \$10,000 or more
- 2004: Arch C. Klumph Society established.













