2024-12-16 Club Board Meeting

Dennis Long reminded the Board that by the February Board Meeting the Club and Foundation Financials should be in a consistent format with what was discussed at the November financial committee meeting.

Karen Hintz reported that Shop with A Cop was a huge success, and the event ran very smoothly this year. As of 2025 the event will be called "Cops & Kids". We need to change our Media Information to reflect the new name. Also, Karen reported we may not need the matching grant going forward.

Dorothy Le reported Christmas Angels gift pick up is going well. Saturday a small group organized at the Dunes Camp for the arrival of the gifts. Sunday and Monday Angel gifts were picked up around the Peninsula. Workers are getting scheduled for the upcoming week. Kathy Long oversees the lunch each day for workers. Everything is on schedule. 114 Families have registered which is 30 families less than last year.

Nancey Olson suggested the Club visit the Senior Center and buy a fundraiser brick with our Rotary Clubs name on it. Nancey Olson made a motion to buy a Brick and Dan Nydegger seconded the motion. With no further discussion the motion was unanimously approved. This motion will be considered at the next Foundation Meeting.

Dan Nydegger made a motion to recommend to the Foundation giving the Scouts \$400 to purchase books. Dorothy seconded the motion and with no further discussion the motion was unanimously approved.
