

ARTICLES OF INCORPORATION

OF

ROTARY CLUB OF NORTH NAPA, CALIFORNIA

I

The name of this corporation shall be ROTARY CLUB OF NORTH NAPA, CALIFORNIA.

II

The purposes for which this corporation is formed are:

- (a) The specific and primary purpose is to operate a community service club.
- (b) The general purposes and powers are to have and exercise all rights and powers conferred on non-profit corporations under the laws of California, including the power to contract, rent, buy or sell personal or real property; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation.

III

This corporation is organized pursuant to the General Non-Profit Corporation Law of the State of California.

IV

The county in this State where the principal office for the transaction of the business of this corporation is located is Napa County.

The authorized number and qualifications of members of the corporation, the different classes of membership, if any, the voting and other rights and privileges of members shall be as set forth in the By-Laws.

VII

pecuniary gain or profit to the members thereof and it is organized solely for nonprofit purposes. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation, which is organized and operated exclusively for charitable, religious and/or scientific purposes and which has established its tax-exempt status under Section

501(c)(3) of the Internal Revenue Code. If this corporation holds any assets on trust, such assets shall be disposed of in such manner as may be directed by decree of the superior court of the county in which this corporation's principal office is located, upon petition therefor by the Attorney General or by any person concerned in the liquidation.

VIII

The name of the unincorporated association which is being incorporated is ROTARY CLUB OF NORTH NAPA, CALIFORNIA.
