

**MEET MOLLY AVILEZ** 

Molly was in the 8th grade where the core value of 'Service above Self' and 'Paying it Forward' took root in her life. It was when she was a student in her Leadership class at Diablo View and had to complete a community service project, that she decided to sponsor a Blood Drive with the American Red Cross. She credits her attendance at Camp Venture one summer with providing her with the knowledge and confidence to tackle such a project. As a result, she collected over 350 pints of blood that earned her the honor of being the youngest blood drive sponsor in the North American Region. # TODAY'S SPEAKER

#### **WE'RE ROOTING FOR THE VAQUITA**



Program Chair Miles Bell introduced us to Kristin Nowell, the Executive Director of Cetacean Action Treasury, who spoke to us this morning about the vaquita, also known as the panda of the ocean, of which there is less than 10 left. In 1997, there were 567.

Kristin told us that the **vaquita porpoise** (*Phocoena sinus*) is found only in a small area in the Upper Gulf of California near the town of San Felipe, Mexico. It is the world's most imperiled mammal, with perhaps fewer than ten remaining. No other species has fallen so far, so fast. Its population has crashed 99% in ten years, because these air-breathing porpoises get entangled in



illegal gillnets and drown. We partner with Mexican organizations to support adoption of fishing gear that poses no risk to vaquitas, and to search for and eliminate illegal nets from the Vaquita Refuge. We also support research on vaquita status, which is critical to convince authorities that the species remains viable.



#### ABOUT THE SPEAKER

**Kristin Nowell** has been working for three years in San Felipe with local partners Pesca ABC and Museo de la Ballena y Ciencias del Mar to save the **vaquita** and train fishermen how to fish with legal fishing gear that does not pose a risk to the species. Before getting involved here, she worked for three decades in wildlife conservation as a big-cat researcher (tigers, lions, cheetahs, and snow leopards) and specialized in analyzing illegal Chinese wildlife trade.

#### **WINE RAFFLE: Update**



# UPDATE FROMUGANDA

Dear Fellow Rotarians,

"We received some good News from our partners, The Rotary Club of Durango High-noon in Durango, Colorado, to support our Medical center with US \$6,000 towards our solar energy initiatives. With these funds we will focus on ensuring that all the lighting and sockets at the center are solar powered.





We are still looking for more support in order to have as many gadgets (e.g. medical and vaccine fridges) and related medical equipment in order to get solar power as this a more reliable and stable power source against the present National grid provider.

Deb and I met the area District Heath Officer (DHO) to officially notify them of our progress and seek support, and guidance on our planned opening of the new Pediatric Wing. That meeting was timely and very revealing as the DHO offered useful tips on enhancing our chances that will enable us to secure financial support from potential financing agencies.

Just so you know, our facility is categorized as a **Healthy Center 3.** DHO strongly suggests and encourages us to upgrade to the **Healthy Center 4** level where mega funding agencies normally focus. To fully qualify we need a Theater. Right now we have the possibility for just minor surgeries like circumcision, dental, and laboratory services. Efforts are underway to get to that level.

This meeting realized a commitment from the District to organize and support a medical camp on site the day of the opening where several potential sponsors are expected to be present. Several medical-related actives will be organized.

For proper arrangements to achieve this, we are likely to extend the official opening from this **March** to early **April.**"


## Length of Service
