A prospective member must be a person in good standing in the community, be able to manage their own time and be sponsored by a Rotarian. Complete the application with your sponsor who will return it to the Salinas Santa Lucia Rotary Membership Committee. The membership committee will review it before the monthly Board meeting (the third Tuesday of each month) and, if within seven days thereafter, there no objections received from membership you are then eligible for membership. You will be contacted by a member of the Membership Committee and a time and place will be arranged on the last Thursday of the month for an orientation. You and your sponsor will attend, together.
