1) CALL TO ORDER AND WELCOME – HOLLENBECK

The meeting was called to order by President Hollenbeck at 12:10. Directors Neil and Weathers were absent.

- 4) SECRETARY'S REPORT-BERGIN

6) OLD BUSINESS

a. Leave of Absence

President Hollenbeck presented research done by Ken Weathers regarding leaves of absences. He identified issues with exempting an absent member from paying charges that other members have to make as a member of the club, and he proposes that we not exempt an absent member from charges. His point makes sense. The prior version identified exempting the member from payment of charges other than club dues. Based on Ken's research, the following idea was presented- A member on a leave of absence must pay their dues plus standard charges for club events. This idea was put into a motion by Matt Conrad and second made by Rich Johnson. Motion Passed, None Opposed.

b. Early Departures

There was a brief discussion around the "rule of 85" and early departures and that it didn't seem proper to charge people who were exempt from attendance for an early departure. A motion was made to exempt "Rule of 85" members from the early departure fee by Dick Chafin and a second by Dick Chafin <Dick can't have made the Second if he made the Motion>. Motion Passed, none opposed.

7) NEW BUSINESS

a. Rule of 85 Exemption

Member Wayne Pearson has requested in writing that he be granted excused absences in accordance with the Club Constitution's Article 9, Section 3, under the policy of the "rule of 85".
